NOTICE OF ORDER AUTHORIZING TEMPORARY CLOSURE OF SECTIONS OF RODNEY STREET AND HARCOURT ROAD, AND PART OF HARCOURT GARDEN

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 1 December 2020 (the 'Order'), authorized:—

- (I) the temporary partial closure of the section of Rodney Street, and the section of Harcourt Road between its junction with Rodney Street and a point about 120 metres east of the junction, as delineated and shown in yellow and pink respectively on the Plan numbered SCL/G37/0068/1; and
- (II) the temporary closure of part of Harcourt Garden, as delineated and shown in orange on the Plan numbered SCL/G37/0068/1,

during the period from 1 January to 31 December 2021 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads and the area of part of Harcourt Garden to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing so as to reach the Secretary for Transport and Housing before the expiration of one year from the closure of the relevant part or parts of the roads and Harcourt Garden or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads and Harcourt Garden affected by the Order. Claims can be submitted via one of the following means:—

Notice is hereby given that further closure of the same part or parts of the roads and Harcourt Garden or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

The roads and Harcourt Garden to be affected

Description of the works and the manner in which the roads and Harcourt Garden will be affected

(a) The section of Rodney Street, and the section of Harcourt Road between its junction with Rodney Street and a point about 120 metres east of the junction, as delineated and shown in yellow and pink respectively on the Plan numbered SCL/G37/0068/1.

Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the associated railway facilities of the Shatin to Central Link, and reinstatement works.

(b) Part of Harcourt Garden, as delineated and shown in orange on the Plan numbered SCL/G37/0068/1.

Part of Harcourt Garden will be temporarily closed to facilitate the construction of the associated railway facilities of the Shatin to Central Link, and reinstatement works.
