NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF SECTIONS OF KIANG SU STREET,
LOK SHAN ROAD, MA TAU WAI ROAD, TAM KUNG ROAD, SAN SHAN ROAD,
PAK TAI STREET, TIN KWONG ROAD, SHEUNG SHING STREET,
KAU PUI LUNG ROAD, SHEUNG HEUNG ROAD, PAU CHUNG STREET,
MAIDSTONE ROAD, KOWLOON CITY ROAD, HA HEUNG ROAD,
TO KWA WAN ROAD, CHI KIANG STREET AND CHATHAM ROAD NORTH;
ANHUI STREET, KIANG HSI STREET AND OLYMPIC GARDEN

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 24 September 2015 (the 'Order'), authorized:—

- (I) the temporary closure of the section of Kiang Su Street between Ma Tau Wai Road and Maidstone Road, as delineated and shown in light pink on the plan numbered SCL/G24/0004/5, with details as follows:
  - (a) during the period from 22 to 31 October 2015, with all carriageways and parts of the footpath widths of the section of the road closed; and
  - (b) during the period from 1 November 2015 to 25 June 2016, with parts of the carriageway and footpath widths of the section of the road closed;
- (II) the temporary closure of the section of Lok Shan Road between Ma Tau Wai Road and Maidstone Road, as delineated and shown in dark brown on the plan numbered SCL/G24/0004/5, with details as follows:
  - (a) during the period from 22 to 31 October 2015, with parts of the carriageway and footpath widths of the section of the road closed; and
  - (b) during the period from 1 November 2015 to 25 June 2016, with all carriageways and parts of the footpath widths of the section of the road closed; and
- (III) (a) the temporary partial closure of the section of Ma Tau Wai Road (and two adjacent footpaths) between a point about 50 metres north of its junction with San Shan Road and a point about 50 metres south of its junction with To Kwa Wan Road, as delineated and shown in orange on the Plans numbered SCL/G23/0004/4, SCL/G24/0004/5 and SCL/G25/0004/4:
  - (b) the temporary partial closure of the section of Tam Kung Road between Ma Tau Wai Road and San Shan Road, the section of San Shan Road

between Ma Tau Wai Road and Pak Tai Street, the section of Pak Tai Street between Ma Tau Wai Road and a point about 30 metres northeast of the junction of Pak Tai Street and Ma Hang Chung Road, the section of Tin Kwong Road between Ma Tau Wai Road and a point about 30 metres northwest of the junction of Tin Kwong Road and Farm Road, and the section of Sheung Shing Street between its junction with Tin Kwong Road and a point about 20 metres southwest of the junction, as delineated and shown in red, dark blue, beige, pink and olive respectively on the Plan numbered SCL/G23/0004/4;

- (c) the temporary partial closure of the section of Kau Pui Lung Road between its junction with Tin Kwong Road and a point about 160 metres south of the junction, the section of Sheung Heung Road between Ma Tau Wai Road and Pau Chung Street, and the section of Pau Chung Street between Sheung Heung Road and Lok Shan Road, as delineated and shown in yellow, light purple and grey respectively on the Plans numbered SCL/G23/0004/4 and SCL/G24/0004/5;
- (d) the temporary partial closure of the section of Maidstone Road between a point about 30 metres north of its junction with Lok Shan Road and a point about 30 metres south of its junction with Kiang Su Street, the section of Lok Shan Road between Maidstone Road and Kau Pui Lung Road, the section of Kiang Su Street between Maidstone Road and Kau Pui Lung Road, the section of Kowloon City Road between Ma Tau Wai Road and Sze Chuen Street, and the section of Ha Heung Road between Chi Kiang Street and Sze Chuen Street, as delineated and shown in dark green, dark blue, red, dark purple and brown respectively on the Plan numbered SCL/G24/0004/5;
- (e) the temporary partial closure of the section of Chi Kiang Street between Ma Tau Wai Road and Ko Shan Road, and the section of Chi Kiang Street between Ma Tau Wai Road and a point about 50 metres southeast of the junction of Chi Kiang Street and To Kwa Wan Road, as delineated and shown in beige on the Plan numbered SCL/G24/0004/5;
- (f) the temporary partial closure of the section of To Kwa Wan Road between Ma Tau Wai Road and Lok Shan Road, and the section of Chatham Road North between its junction with Ma Tau Wai Road and a point about 130 metres southwest of the junction, as delineated and shown in pink and light blue respectively on the Plans numbered SCL/G24/0004/5 and SCL/G25/0004/4;
- (g) the temporary partial closure of Anhui Street, as delineated and shown in light green on the Plan numbered SCL/G24/0004/5;
- (h) the temporary partial closure of Kiang Hsi Street, as delineated and shown in olive on the Plans numbered SCL/G24/0004/5 and SCL/G25/0004/4; and

 the temporary partial closure of Olympic Garden, as delineated and shown in yellow on the Plans numbered SCL/G19/0005/4 and SCL/G22/0005/4

during the period from 22 October 2015 to 21 October 2016,

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads and Olympic Garden to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the roads and Olympic Garden or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads and Olympic Garden affected by the Order.

Notice is hereby given that further closure of the same part or parts of the roads and Olympic Garden or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

## SCHEDULE

The roads and Olympic Garden to be affected

Description of the works and the manner in which the roads and Olympic Garden will be affected

(a) The section of Kiang Su Street between Ma Tau Wai Road and Maidstone Road, as delineated and shown in light pink on the Plan numbered SCL/G24/0004/5. During the period from 22 to 31 October 2015, all carriageways and parts of the footpath widths will be temporarily closed to facilitate the construction of the railway station, railway station entrance and the associated railway facilities of the Shatin to Central Link

During the period from 1 November 2015 to 25 June 2016, parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the railway station, railway station entrance and the associated railway facilities of the Shatin to Central Link.

(b) The section of Lok Shan Road between Ma Tau Wai Road and Maidstone Road, as delineated and shown in dark brown on the Plan numbered SCL/G24/0004/5. During the period from 22 to 31 October 2015, parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the railway station, railway station entrance and the associated railway facilities of the Shatin to Central Link

During the period from 1 November 2015 to 25 June 2016, all carriageways and parts of the footpath widths will be temporarily closed to facilitate the construction of the railway station, railway station entrance and the associated railway facilities of the Shatin to Central Link

The roads and Olympic Garden to be affected

(c) The section of Ma Tau Wai Road (and two adjacent footpaths) between a point about 50 metres north of its junction with San Shan Road and a point about 50 metres south of its junction with To Kwa Wan Road, as delineated and shown in orange on the Plans numbered SCL/G23/0004/4, SCL/G24/0004/5 and SCL/G25/0004/4. Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the railway tunnel, railway station and the associated railway facilities of the Shatin to Central Link

(d) The section of Tam Kung Road between Ma Tau Wai Road and San Shan Road. the section of San Shan Road between Ma Tau Wai Road and Pak Tai Street, the section of Pak Tai Street between Ma Tau Wai Road and a point about 30 metres northeast of the junction of Pak Tai Street and Ma Hang Chung Road. the section of Tin Kwong Road between Ma Tau Wai Road and a point about 30 metres northwest of the junction of Tin Kwong Road and Farm Road, and the section of Sheung Shing Street between its junction with Tin Kwong Road and a point about 20 metres southwest of the iunction, as delineated and shown in red, dark blue, beige, pink and olive respectively on the Plan numbered SCL/G23/0004/4

Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the railway tunnel, railway station and the associated railway facilities of the Shatin to Central Link

(e) The section of Kau Pui Lung Road between its junction with Tin Kwong Road and a point about 160 metres south of the junction, and the section of Sheung Heung Road between Ma Tau Wai Road and Pau Chung Street, as delineated and shown in yellow and light purple respectively on the Plans numbered SCL/G23/0004/4 and SCL/G24/0004/5 Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the railway tunnel, railway station and the associated railway facilities of the Shatin to Central Link The roads and Olympic Garden to be affected

Description of the works and the manner in which the roads and Olympic Garden will be affected

(f) The section of Pau Chung Street between Sheung Heung Road and Lok Shan Road, as delineated and shown in grey on the Plans numbered SCL/G23/0004/4 and SCL/G24/0004/5. Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the railway station, railway station entrance and the associated railway facilities of the Shatin to Central Link

(g) The section of Maidstone Road between a point about 30 metres north of its junction with Lok Shan Road and a point about 30 metres south of its junction with Kiang Su Street, the section of Kiang Su Street between Maidstone Road and Kau Pui Lung Road, the section of Kowloon City Road between Ma Tau Wai Road and Sze Chuen Street, and the section of Ha Heung Road between Chi Kiang Street and Sze Chuen Street, as delineated and shown in dark green, red, dark purple and brown respectively on the Plan numbered SCL/G24/0004/5. Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the railway tunnel, railway station and the associated railway facilities of the Shatin to Central Link

(h) The section of Lok Shan Road between Maidstone Road and Kau Pui Lung Road, as delineated and shown in dark blue on the Plan numbered SCL/G24/0004/5 Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the railway station, railway station entrance and the associated railway facilities of the Shatin to Central Link

(i) The section of Chi Kiang Street between Ma Tau Wai Road and Ko Shan Road, and the section of Chi Kiang Street between Ma Tau Wai Road and a point about 50 metres southeast of the junction of Chi Kiang Street and To Kwa Wan Road, as delineated and shown in beige on the Plan numbered SCL/G24/0004/5. Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the railway tunnel, railway station and the associated railway facilities of the Shatin to Central Link The roads and Olympic Garden to be affected

(j) The section of To Kwa Wan Road between Ma Tau Wai Road and Lok Shan Road, as delineated and shown in pink on the Plans numbered SCL/G24/0004/5 and SCL/G25/0004/4. Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the railway tunnel, railway station and the associated railway facilities of the Shatin to Central Link.

(k) The section of Chatham Road North between its junction with Ma Tau Wai Road and a point about 130 metres southwest of the junction, and Kiang Hsi Street, as delineated and shown in light blue and olive respectively on the Plans numbered SCL/G24/0004/5 and SCL/G25/0004/4. Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the railway tunnel and the associated railway facilities of the Shatin to Central Link

 Anhui Street, as delineated and shown in light green on the Plan numbered SCL/G24/0004/5. Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the railway tunnel, railway station and the associated railway facilities of the Shatin to Central Link.

(m) Olympic Garden, as delineated and shown in yellow on the Plans numbered SCL/G19/0005/4 and SCL/G22/0005/4. Parts of Olympic Garden will be temporarily closed to facilitate the construction of the railway station entrance and the associated railway facilities of the Shatin to Central Link
