SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF PART OF
MA CHAI HANG RECREATION GROUND, PARTS OF THE FOOTBRIDGE
TO THE SOUTHWEST OF MA CHAI HANG RECREATION GROUND AND
A SECTION OF MA CHAI HANG ROAD**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 18 January 2016 (the ‘Order’), authorized:–

- (I) the temporary closure of part of Ma Chai Hang Recreation Ground, as delineated and shown in green on the Plan numbered SCL/G07/0012/4;
- (II) the temporary closure of part of the footbridge to the southwest of Ma Chai Hang Recreation Ground, as delineated and shown in red on the Plan numbered SCL/G07/0012/4;
- (III) the temporary partial closure of part of the footbridge to the southwest of Ma Chai Hang Recreation Ground, as delineated and shown in pink on the Plan numbered SCL/G07/0012/4; and
- (IV) the temporary partial closure of the section of Ma Chai Hang Road between its junction with Chuk Yuen Road and the roundabout at its junction with Fung Mo Street, as delineated and shown in orange on the Plan numbered SCL/G07/0012/4,

during the period from 1 March 2016 to 28 February 2017 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the area of Ma Chai Hang Recreation Ground, the parts of the footbridge and the section of the road to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of Ma Chai Hang Recreation Ground, the footbridge and the road or the extinction, modification or restriction of his private right in respect of the relevant part or parts of Ma Chai Hang Recreation Ground, the footbridge and the road affected by the Order.

Notice is hereby given that further closure of the same part or parts of Ma Chai Hang Recreation Ground, the footbridge and the road or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
