SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF PART OF WAN CHAI SPORTS GROUND AND
WAN CHAI FERRY PUBLIC TRANSPORT INTERCHANGE; TEMPORARY
CLOSURE OF SECTIONS OF VICTORIA PARK ROAD, HARBOUR ROAD AND
FENWICK PIER STREET; AND LUNG KING STREET; AND TEMPORARY
ALTERATION OF SECTIONS OF MARSH ROAD, HUNG HING ROAD,
TONNOCHY ROAD, FLEMING ROAD, EXPO DRIVE EAST AND EXPO DRIVE
CENTRAL; AND CONVENTION AVENUE**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 9 December 2021 (the ‘Order’), authorized:–

- (I) (a) the temporary closure of part of Wan Chai Sports Ground, as delineated and shown in pink on the Plans numbered SCL/G34/0070/1 and SCL/G35/0070/1;
- (b) the temporary closure of Wan Chai Ferry Public Transport Interchange, as delineated and shown in green on the Plan numbered SCL/G35/0070/1;
- (c) the temporary partial closure of the section of Victoria Park Road between a point about 30 metres northwest of its junction with its slip roads and a point about 70 metres northeast of the junction, as delineated and shown in light blue on the Plan numbered SCL/G34/0070/1;
- (d) the temporary partial closure of the section of Harbour Road between its junction with Tonnochy Road and a point about 70 metres west of the junction, as delineated and shown in red on the Plans numbered SCL/G34/0070/1 and SCL/G35/0070/1;
- (e) the temporary partial closure of the section of Fenwick Pier Street between its junction with Convention Avenue and a point about 230 metres west of the junction, as delineated and shown in dark purple on the Plan numbered SCL/G36/0070/1; and
- (f) the temporary partial closure of Lung King Street, as delineated and shown in dark grey on the Plan numbered SCL/G36/0070/1,

during the period from 1 January to 30 June 2022; and

- (II) (a) the temporary alteration of the section of Marsh Road between its junction with Hung Hing Road and a point about 30 metres south of the junction, as delineated and shown in dark blue on the Plan numbered SCL/G34/0070/1;
- (b) the temporary alteration of the section of Hung Hing Road between its junction with Convention Avenue and a point about 330 metres northeast of the junction, and the section of Tonnochy Road between its junction with Hung Hing Road and its junction with Harbour Road, as delineated and shown in yellow and orange respectively on the Plans numbered SCL/G34/0070/1 and SCL/G35/0070/1;
- (c) the temporary alteration of the section of Fleming Road between its junction with Harbour Road and its junction with Convention Avenue, the section of Expo Drive East between its junction with Convention Avenue and a point about 180 metres north of the junction, and the section of Expo Drive Central between its junction with Expo Drive East and a point about 35 metres west of the junction, as delineated and shown in purple, blue and grey respectively on the Plan numbered SCL/G35/0070/1; and
- (d) the temporary alteration of Convention Avenue, as delineated and shown in beige on the Plans numbered SCL/G35/0070/1 and SCL/G36/0070/1,

during the period from 1 January to 30 June 2022,

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the area of part of Wan Chai Sports Ground, Wan Chai Ferry Public Transport Interchange and the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered SCL/G34/0070/1, SCL/G35/0070/1 and SCL/G36/0070/1 (the 'Plans') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing so as to reach the Secretary for Transport and Housing before the expiration of one year from the closure/alteration of the relevant part or parts of Wan Chai Sports Ground, Wan Chai Ferry Public Transport Interchange and the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of Wan Chai Sports Ground, Wan Chai Ferry Public Transport Interchange and the roads affected by the Order. Claims can be submitted via one of the following means:–
