NOTICE OF ORDER AUTHORIZING TEMPORARY CLOSURE OF THE OPEN SPACES IN WINSLOW STREET PLAYGROUND, NEAR CHATHAM ROAD NORTH AND ITS LINK ROAD, AND NEAR OI SEN PATH AND CHATHAM ROAD NORTH

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 28 November 2012 (the 'Order'), authorized the temporary closure of the open spaces in Winslow Street Playground, near Chatham Road North and its link road, and near Oi Sen Path and Chatham Road North, as delineated and shown in red, blue and green respectively on the Plan numbered SCL/G27/0006/1 during the period from 21 December 2012 to 20 December 2013 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the open spaces to be affected and the manner in which they will be affected is given in the Schedule below.

Notice is hereby given that further closure of the same part or parts of the open spaces or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
