**NOTICE OF ORDER AUTHORIZING  
TEMPORARY CLOSURE OF  
PARTS OF THE FOOTBRIDGES IN TUNNEL APPROACH REST GARDEN;  
PARTS OF TUNNEL APPROACH REST GARDEN;  
SECTIONS OF SLIP ROADS FROM GLOUCESTER ROAD TO  
CROSS HARBOUR TUNNEL, FROM GLOUCESTER ROAD TO  
CANAL ROAD FLYOVER, AND FROM CROSS HARBOUR TUNNEL TO  
VICTORIA PARK ROAD, AND A SECTION OF VICTORIA PARK ROAD**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 27 November 2019 (the ‘Order’), authorized:-

- (I) the temporary partial closure of part of the footbridge connecting Percival Street and Tunnel Approach Rest Garden, as delineated and shown in green on the Plan numbered SCL/G34/0031/6 during the period from 1 January to 31 December 2020; and
- (II) (a) the temporary closure of part of the footbridge connecting Wan Shing Street and Gloucester Road, as delineated and shown in purple on the Plan numbered SCL/G34/0031/6;
- (b) the temporary closure of part of Tunnel Approach Rest Garden (near Canal Road Flyover), as delineated and shown in yellow on the Plan numbered SCL/G34/0031/6;
- (c) the temporary partial closure of part of Tunnel Approach Rest Garden (near Victoria Park Road), as delineated and shown in pink on the Plan numbered SCL/G34/0031/6;
- (d) the temporary partial closure of sections of the slip roads from Gloucester Road to Cross Harbour Tunnel, from Gloucester Road to Canal Road Flyover, and from Cross Harbour Tunnel to Victoria Park Road, as delineated and shown in red, brown and beige respectively on the Plan numbered SCL/G34/0031/6; and
- (e) the temporary partial closure of the section of Victoria Park Road between a point about 30 metres northwest of its junction with its slip roads and a point about 120 metres northeast of the junction, as delineated and shown in blue on the Plan numbered SCL/G34/0031/6,

during the period from 4 February to 31 December 2020,

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the parts of the footbridges, the areas of parts of Tunnel Approach Rest Garden and the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of this notice will be affixed on or near the footbridges, Tunnel Approach Rest Garden and the roads affected by the Order on 13 December 2019.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing so as to reach the Secretary for Transport and Housing before the expiration of one year from the closure of the relevant part or parts of the footbridges, Tunnel Approach Rest Garden and the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the footbridges, Tunnel Approach Rest Garden and the roads affected by the Order. Claims can be submitted via one of the following means:-

- (1) by post or by hand to the Transport and Housing Bureau's Drop-in Box No. 6 located at the 2nd Floor Entrance, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong. The box is available for use between 8:00 a.m. and 7:00 p.m. from Monday to Friday (except public holidays);

Notice is hereby given that further closure of the same part or parts of the footbridges, Tunnel Approach Rest Garden and the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
