PERMANENT ALTERATION OF A STAIRCASE AND FOOTPATH NEAR
THE JUNCTION OF SHATIN PASS ROAD AND FUNG TAK ROAD; AND
TEMPORARY CLOSURE OF SECTIONS OF WONG TAI SIN ROAD,
SHATIN PASS ROAD, YING FUNG LANE, FUNG TAK ROAD, AND
THE ACCESS ROAD CONNECTING WONG TAI SIN ROAD AND
SIK SIK YUEN WONG TAI SIN TEMPLE

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 23 November 2018 (the 'Order'), authorized:—

- (I) the permanent alteration of the staircase and footpath near the junction of Shatin Pass Road and Fung Tak Road, as delineated and shown in red on the Plan numbered SCL/G08/0008/5 with effect from 21 December 2018; and
- (II) (a) the temporary partial closure of the section of Wong Tai Sin Road between its junction with Shatin Pass Road and a point about 85 metres west of the junction, the section of Shatin Pass Road between a point about 65 metres north of its junction with Fung Tak Road and a point about 50 metres southwest of the junction, the section of Ying Fung Lane between its junction with Fung Tak Road and a point about 20 metres south of the junction, and the section of Fung Tak Road between its junction with Shatin Pass Road and a point about 75 metres east of the junction, as delineated and shown in green, blue, brown and yellow respectively on the Plan numbered SCL/G08/0008/5; and
 - (b) the temporary partial closure of the section of the access road connecting Wong Tai Sin Road and Sik Sik Yuen Wong Tai Sin Temple between its junction with Wong Tai Sin Road and a point about 40 metres southwest of the junction, as delineated and shown in pink on the Plan numbered SCL/G08/0008/5.

during the period from 21 December 2018 to 20 December 2019,

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the staircase, the footpath and the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing so as to reach the Secretary for Transport and Housing before the expiration of one year from the alteration/closure of the relevant part or parts of the staircase, the footpath and the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the staircase, the footpath and the roads affected by the Order. Claims can be submitted via one of the following means: —

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

SCHEDULE

The staircase, the footpath and the roads to be affected

Description of the works and the manner in which the staircase, the footpath and the roads will be affected

(a) The staircase and footpath near the junction of Shatin Pass Road and Fung Tak Road, as delineated and shown in red on the Plan numbered SCL/G08/0008/5 The staircase and footpath will be permanently altered for the provision of the associated railway facilities of the Shatin to Central Link.

(b) The section of Wong Tai Sin Road between its junction with Shatin Pass Road and a point about 85 metres west of the junction, the section of Shatin Pass Road between a point about 65 metres north of its junction with Fung Tak Road and a point about 50 metres southwest of the junction, the section of Ying Fung Lane between its junction with Fung Tak Road and a point about 20 metres south of the junction, and the section of Fung Tak Road between its junction with Shatin Pass Road and a point about 75 metres east of the junction, as delineated and shown in green, blue, brown and vellow respectively on the Plan numbered SCL/G08/0008/5.

Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the associated railway facilities of the Shatin to Central Link, and reinstatement works.

(c) The section of the access road connecting Wong Tai Sin Road and Sik Sik Yuen Wong Tai Sin Temple between its junction with Wong Tai Sin Road and a point about 40 metres southwest of the junction, as delineated and shown in pink on the Plan numbered SCL/G08/0008/5. Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the associated railway facilities of the Shatin to Central Link, and reinstatement works.
