

**RAILWAYS ORDINANCE (Chapter 519)**  
**(Order under section 22(1))**

**SHATIN TO CENTRAL LINK**

**AUTHORIZATION FOR  
TEMPORARY CLOSURE OF  
PARTS OF THE FOOTBRIDGES IN TUNNEL APPROACH REST GARDEN;  
PARTS OF TUNNEL APPROACH REST GARDEN;  
SECTIONS OF SLIP ROADS FROM GLOUCESTER ROAD TO  
CROSS HARBOUR TUNNEL, FROM GLOUCESTER ROAD TO  
CANAL ROAD FLYOVER, AND FROM CROSS HARBOUR TUNNEL TO  
VICTORIA PARK ROAD, AND A SECTION OF VICTORIA PARK ROAD**

In exercise of the powers delegated by the Secretary for Transport and Housing, I, by this order made under section 22(1)(a) of the Railways Ordinance (Chapter 519), authorize:-

- (I) the temporary partial closure of part of the footbridge connecting Percival Street and Tunnel Approach Rest Garden, as delineated and shown in green on the Plan numbered SCL/G34/0031/6 during the period from 1 January to 31 December 2019; and
  
- (II) (a) the temporary closure of part of the footbridge connecting Wan Shing Street and Gloucester Road, as delineated and shown in purple on the Plan numbered SCL/G34/0031/6;
  
- (b) the temporary closure of part of Tunnel Approach Rest Garden (near Canal Road Flyover), as delineated and shown in yellow on the Plan numbered SCL/G34/0031/6;
  
- (c) the temporary partial closure of part of Tunnel Approach Rest Garden (near Victoria Park Road), as delineated and shown in pink on the Plan numbered SCL/G34/0031/6;
  
- (d) the temporary partial closure of sections of the slip roads from Gloucester Road to Cross Harbour Tunnel, from Gloucester Road to Canal Road Flyover, and from Cross Harbour Tunnel to Victoria Park Road, as delineated and shown in red, brown and beige respectively on the Plan numbered SCL/G34/0031/6; and
  
- (e) the temporary partial closure of the section of Victoria Park Road between a point about 30 metres northwest of its junction with its slip roads and a point about 120 metres northeast of the junction, as delineated and shown in blue on the Plan numbered SCL/G34/0031/6,

during the period from 4 February 2019 to 3 February 2020.

I further declare under section 22(1)(c) that all public or private rights in, upon, under or over (i) the part of the footbridge as described in (I) above during the period from 1 January to 31 December 2019; and (ii) the part of the footbridge, parts of Tunnel Approach Rest Garden and the sections of the roads as described in (II) above during the period from 4 February 2019 to 3 February 2020, shall be extinguished, modified or restricted, as the case may be.
