SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
PERMANENT CLOSURE OF PARTS OF OLYMPIC GARDEN; AND
TEMPORARY CLOSURE OF PARTS OF OLYMPIC GARDEN AND
SUNG WONG TOI PLAYGROUND**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 4 December 2018 (the 'Order'), authorized:—

- (I) the permanent closure of parts of Olympic Garden, as delineated and shown in red on the Plans numbered SCL/G19/0042/6 and SCL/G22/0042/6 with effect from 31 December 2018; and
- (II) (a) the temporary partial closure of part of Olympic Garden, as delineated and shown in yellow on the Plans numbered SCL/G19/0042/6 and SCL/G22/0042/6; and

(b) the temporary closure of part of Sung Wong Toi Playground, as delineated and shown in green on the Plans numbered SCL/G19/0042/6 and SCL/G22/0042/6,

during the period from 31 December 2018 to 30 June 2019,

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the areas of parts of Olympic Garden and Sung Wong Toi Playground to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered SCL/G19/0042/6 and SCL/G22/0042/6 (the 'Plans') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

A copy of this notice will be affixed on or near Olympic Garden and Sung Wong Toi Playground affected by the Order on 14 December 2018.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing so as to reach the Secretary for Transport and Housing before the expiration of one year from the closure of the relevant part or parts of Olympic Garden and Sung Wong Toi Playground or the extinction, modification or restriction of his private right in respect of the relevant part or parts of Olympic Garden and Sung Wong Toi Playground affected by the Order. Claims can be submitted via one of the following means:-

- (1) by post or by hand to the Transport and Housing Bureau's Drop-in Box No. 6 located at the 2nd Floor Entrance, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong. The box is available for use between 8:00 a.m. and 7:00 p.m. from Monday to Friday (except public holidays);

Notice is hereby given that further closure of the same part or parts of Olympic Garden and Sung Wong Toi Playground or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
