A description of the works to be carried out, the areas of the Government foreshore and seabed to be affected and the manner in which they will be affected is given in the Schedule below.

Notice is hereby given that further works over and upon the same part or parts of the Government foreshore and sea-bed or any of such part or parts may be required upon expiration of the Order. Details of any further order for works will be published if and when such an order is made.

Description of the works and the manner in which the Government foreshore and sea-bed will be affected

(a) An area of Victoria Harbour (outside the former International Mail Centre), as delineated and shown in yellow on the Plans numbered SCL/G28/0043/2 and SCL/G29/0043/2. Temporary reclamation, dredging works, demolition and reprovision of part of the fender piles and construction of the railway tunnel over and upon the Government foreshore and sea-bed to facilitate the construction of the railway works of the Shatin to Central Link.

(b) An area of Victoria Harbour, as delineated and shown in green on the Plan numbered SCL/G29/0043/2. Dredging works and construction of the railway tunnel over and upon the Government foreshore and sea-bed to facilitate the construction of the railway works of the Shatin to Central Link.
