**SOUTH ISLAND LINE (EAST)**

**NOTICE OF ORDER AUTHORIZING  
PERMANENT CLOSURE OF AP LEI CHAU MAIN STREET  
TEMPORARY SITTING-OUT AREA, AND SECTIONS OF  
LEI TUNG ESTATE ROAD AND YI NAM ROAD; AND  
TEMPORARY CLOSURE OF SECTIONS OF LEI TUNG ESTATE ROAD,  
AP LEI CHAU BRIDGE ROAD, YI NAM ROAD AND SOUTH HORIZON DRIVE;  
AP LEI CHAU DRIVE AND LEE NAM ROAD, AND A FOOTPATH ADJACENT TO  
AP LEI CHAU MAIN STREET TEMPORARY SITTING-OUT AREA**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 12 May 2016 (the 'Order'), authorized:—

- (A) (I) the permanent closure of Ap Lei Chau Main Street Temporary Sitting-out Area, as delineated and shown in light green on the Plan numbered SILE/G11/0004/5;
- (II) the permanent closure of part of the carriageway and footpath widths of the section of Lei Tung Estate Road adjacent to the Lei Tung Commercial Centre (Phase 1), as delineated and shown in dark purple on the Plans numbered SILE/G11/0004/5 and SILE/G12/0004/5; and
- (III) the permanent closure of part of the carriageway and footpath widths of the section of Yi Nam Road between a point about 50 metres north of its junction with South Horizon Drive and a point about 75 metres north of the junction, as delineated and shown in red on the Plan numbered SILE/G13/0004/5,

with effect from 27 May 2016;

- (B) the temporary closure of the roads and footpath in the vicinity of Lei Tung Estate and Main Street, Ap Lei Chau –
  - (I) the temporary partial closure of sections of Lei Tung Estate Road adjacent to the Lei Tung Commercial Centre (Phase 1), as delineated and shown in dark green on the Plans numbered SILE/G11/0004/5 and SILE/G12/0004/5, during the period from 27 May to 30 September 2016; and
  - (II) (a) the temporary partial closure of the section of Lei Tung Estate Road between its junction with Ap Lei Chau Drive and a point about 110 metres south of the junction, and the section of Lei Tung Estate Road adjacent to the Lei Tung Commercial Centre (Phase 1), Tung Sing House and Tung Hing House, as delineated and shown in brown on the Plans numbered SILE/G11/0004/5 and SILE/G12/0004/5;

- (b) the temporary partial closure of the section of Ap Lei Chau Bridge Road between a point about 250 metres northeast of its junction with Ap Lei Chau Drive and a point about 60 metres west of its junction with Yi Nam Road, as delineated and shown in yellow on the Plans numbered SILE/G11/0004/5 and SILE/G13/0004/5;
- (c) the temporary partial closure of Ap Lei Chau Drive, as delineated and shown in pink on the Plan numbered SILE/G11/0004/5; and
- (d) the temporary partial closure of the footpath adjacent to Ap Lei Chau Main Street Temporary Sitting-out Area, as delineated and shown in light blue on the Plan numbered SILE/G11/0004/5,

during the period from 27 May to 31 December 2016; and

(C) the temporary closure of the roads in the vicinity of South Horizons –

- (I) the temporary closure of the section of Yi Nam Road between its junction with Lee Nam Road and a point about 50 metres northwest of the junction, as delineated and shown in green on the Plan numbered SILE/G13/0004/5, with details as follows:
  - (a) during the period from 15 July to 31 August 2016, with all carriageway and parts of the footpath widths of the section of the road closed; and
  - (b) during the period from 27 May to 31 December 2016, except the period specified in (C)(I)(a) above, with parts of the carriageway and footpath widths of the section of the road closed; and
- (II) (a) the temporary partial closure of the section of Yi Nam Road between a point about 50 metres northwest of its junction with Lee Nam Road and its junction with Ap Lei Chau Bridge Road, and the section of South Horizon Drive between its junction with Yi Nam Road and a point about 20 metres west of the junction, as delineated and shown in dark purple and orange respectively on the Plan numbered SILE/G13/0004/5; and
- (b) the temporary partial closure of Lee Nam Road, as delineated and shown in light blue on the Plans numbered SILE/G12/0004/5 and SILE/G13/0004/5,

during the period from 27 May to 31 December 2016,

for the purposes of or incidental to the railway scheme of the South Island Line (East). A description of the works to be carried out, Ap Lei Chau Main Street Temporary Sitting-out Area, the sections of the roads and the footpath to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered SILE/G11/0004/5, SILE/G12/0004/5 and SILE/G13/0004/5 (the ‘Plans’) may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:–

A copy of this notice will be affixed on or near Ap Lei Chau Main Street Temporary Sitting-out Area, the roads and the footpath affected by the Order on 20 May 2016.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of Ap Lei Chau Main Street Temporary Sitting-out Area, the roads and the footpath or the extinction, modification or restriction of his private right in respect of the relevant part or parts of Ap Lei Chau Main Street Temporary Sitting-out Area, the roads and the footpath affected by the Order.

Notice is hereby given that further closure of the same part or parts of the roads and the footpath or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

(c) Part of the carriageway and footpath widths of the section of Yi Nam Road between a point about 50 metres north of its junction with South Horizon Drive and a point about 75 metres north of the junction, as delineated and shown in red on the Plan numbered SILE/G13/0004/5.	Part of the carriageway and footpath widths will be permanently closed for the provision of the railway station entrance and the associated railway facilities of the South Island Line (East).
(d) Sections of Lei Tung Estate Road adjacent to the Lei Tung Commercial Centre (Phase 1), as delineated and shown in dark green on the Plans numbered SILE/G11/0004/5 and SILE/G12/0004/5.	Parts of the footpath widths will be temporarily closed to facilitate the construction of the railway tunnel, the railway station and the associated railway facilities of the South Island Line (East), and the road reinstatement works.
(e) The section of Lei Tung Estate Road between its junction with Ap Lei Chau Drive and a point about 110 metres south of the junction, and the section of Lei Tung Estate Road adjacent to the Lei Tung Commercial Centre (Phase 1), Tung Sing House and Tung Hing House, as delineated and shown in brown on the Plans numbered SILE/G11/0004/5 and SILE/G12/0004/5.	Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the railway tunnel, the railway station and the associated railway facilities of the South Island Line (East), and the road reinstatement works.

- (f) The section of Ap Lei Chau Bridge Road between a point about 250 metres northeast of its junction with Ap Lei Chau Drive and a point about 60 metres west of its junction with Yi Nam Road, as delineated and shown in yellow on the Plans numbered SILE/G11/0004/5 and SILE/G13/0004/5.
- (g) Ap Lei Chau Drive, as delineated and shown in pink on the Plan numbered SILE/G11/0004/5.
- (h) The footpath adjacent to Ap Lei Chau Main Street Temporary Sitting-out Area, as delineated and shown in light blue on the Plan numbered SILE/G11/0004/5.
- (i) The section of Yi Nam Road between its junction with Lee Nam Road and a point about 50 metres northwest of the junction, as delineated and shown in green on the Plan numbered SILE/G13/0004/5.

Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the railway tunnel, the railway station and the associated railway facilities of the South Island Line (East), and the road reinstatement works.

Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the ventilation facilities and the associated railway facilities of the South Island Line (East), and the road reinstatement works.

Parts of the footpath widths will be temporarily closed to facilitate the construction of the railway station entrances and the associated railway facilities of the South Island Line (East).

During the period from 15 July to 31 August 2016, all carriageway and parts of the footpath widths will be temporarily closed to facilitate the construction of the railway station, the ventilation and plant building and the associated railway facilities of the South Island Line (East), and the road reinstatement works.

During the period from 27 May to 31 December 2016, except the period specified above, parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the railway station, the ventilation and plant building and the associated railway facilities of the South Island Line (East), and the road reinstatement works.
