NOTICE OF ORDER AUTHORIZING TEMPORARY CLOSURE OF SECTIONS OF NAM FUNG ROAD, WONG CHUK HANG PATH, NAM FUNG PATH, TIN WAN PRAYA ROAD, VICTORIA ROAD AND SHA WAN DRIVE

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 17 May 2011 (the 'Order'), authorized:—

- (I) the temporary partial closure of sections of Nam Fung Road between its junction with Wong Chuk Hang Road and Nam Fung Road Rest Garden, sections of Wong Chuk Hang Path, and sections of Nam Fung Path between its junction with Nam Fung Road and the roundabout near St. Paul's Co-educational College Primary School;
- (II) the temporary partial closure of sections of Tin Wan Praya Road between its junction with Wah Kwai Road and a point about 130 metres east of the junction; and
- (III) the temporary partial closure of sections of Victoria Road between a point about 70 metres north of its junction with Sha Wan Drive and a point about 180 metres south of the junction, and sections of Sha Wan Drive between its junction with Victoria Road and a point about 200 metres south of the junction,

during the period from 27 May 2011 to 26 May 2012 for the purposes of or incidental to the railway scheme of the South Island Line (East). A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 15th Floor, Murray Building, Garden Road, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order.

Notice is hereby given that further temporary closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for temporary closure will be published if and when such an order is made.

SCHEDULE

The roads to be affected

- (a) Sections of Nam Fung Road between its junction with Wong Chuk Hang Road and Nam Fung Road Rest Garden, as delineated and shown in yellow on the Plans numbered SILE/G07/0002/1 and SILE/G08/0002/1.
- (b) Sections of Wong Chuk Hang Path, as delineated and shown in blue on the Plans numbered SILE/G07/0002/1 and SILE/G08/0002/1.
- (c) Sections of Nam Fung Path between its junction with Nam Fung Road and the roundabout near St. Paul's Co-educational College Primary School, as delineated and shown in green on the Plans numbered SILE/G07/0002/1 and SILE/G08/0002/1.
- (d) Sections of Tin Wan Praya Road between its junction with Wah Kwai Road and a point about 130 metres east of the junction, as delineated and shown in yellow on the Plan numbered SILE/G14/0002/1.
- (e) Sections of Victoria Road between a point about 70 metres north of its junction with Sha Wan Drive and a point about 180 metres south of the junction, and sections of Sha Wan Drive between its junction with Victoria Road and a point about 200 metres south of the junction, as delineated and shown in yellow and green respectively on the Plan numbered SILE/G17/0002/1.

Description of the works and the manner in which the roads will be affected

Parts of the carriageway and footpath widths will be temporarily closed for the construction of the railway tunnel, ventilation and plant building, and the associated railway facilities of the South Island Line (East).

Parts of the carriageway and footpath widths will be temporarily closed in connection with the construction of the railway tunnel, railway viaduct and the associated railway facilities of the South Island Line (East).

Parts of the carriageway and footpath widths will be temporarily closed for the construction of the railway tunnel, railway viaduct and the associated railway facilities of the South Island Line (East).

Parts of the carriageway and footpath widths will be temporarily closed in connection with the works at the temporary works area for the South Island Line (East).

Parts of the carriageway and footpath widths will be temporarily closed for the associated roads improvement works and slope stabilization works for the South Island Line (East).
