SOUTH ISLAND LINE (EAST)

NOTICE OF ORDER AUTHORIZING RECLAMATION OF AND
OTHER WORKS OVER AND UPON THE GOVERNMENT FORESHORE AND
SEA-BED AT SECTIONS OF WONG CHUK HANG NULLAH AND
A SECTION OF THE ABERDEEN CHANNEL

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 17 May 2011 (the ‘Order’), authorized:—

- (I) the reclamation of and other works over and upon the Government foreshore and sea-bed at a section of Wong Chuk Hang Nullah (along Ocean Park Road and Heung Yip Road) between the roundabout at the eastern end of Ocean Park Road and a point near Heung Yip Road Zone Substation, as delineated and shown in pink on Plans numbered SILE/G08/0005/1 and SILE/G09/0005/1;
- (II) the reclamation of and other works over and upon the Government foreshore and sea-bed at a section of Wong Chuk Hang Nullah at the southern end of Heung Yip Road (near Aberdeen Police Station), and a section of Wong Chuk Hang Nullah at the southeast end of Kwun Hoi Path, as delineated and shown in blue on Plan numbered SILE/G10/0005/1; and
- (III) the reclamation of and other works over and upon the Government foreshore and sea-bed at a section of Aberdeen Channel at the southeast side of Ap Lei Chau Bridge Road, as delineated and shown in yellow on Plan numbered SILE/G10/0005/1 and SILE/G11/0005/1,

with effect from 27 May 2011 for the purposes of or incidental to the railway scheme of the South Island Line (East). A description of the works to be carried out and the areas of the foreshore and sea-bed to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered SILE/G08/0005/1, SILE/G09/0005/1, SILE/G10/0005/1 and SILE/G11/0005/1 (the ‘Plans’) may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

A copy of this notice will be affixed on or near the areas of the Government foreshore and sea-bed affected by the Order on 20 May 2011.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 15th Floor, Murray Building, Garden Road, Hong Kong so as to reach the Secretary before the expiration of one year from the date of extinction, modification or restriction of his private right over the Government foreshore and sea-bed affected by the Order.

SCHEDULE

<i>The foreshore and sea-bed affected</i>	<i>Description of the works and the manner in which the foreshore and sea-bed will be affected</i>
(a) An area of the Government foreshore and sea-bed at a section of Wong Chuk Hang Nullah (along Ocean Park Road) and Heung Yip Road between the roundabout at the eastern end of Ocean Park Road and a point near Heung Yip Road Zone Substation, as delineated and shown in pink on the Plans numbered SILE/G08/0005/1 and SILE/G09/0005/1.	The works involve the modification of parts of Wong Chuk Hang Nullah, (including demolition of parts of the Wong Chuk Hang Nullah wall and conversion of a section of Wong Chuk Hang Nullah to box culverts), the construction of the railway viaduct foundations, and the road improvement works at Ocean Park Road and Heung Yip Road, for the construction of the railway station and the public transport interchange at Wong Chuk Hang of the South Island Line (East).
(b) An area of the Government foreshore and sea-bed at a section of Wong Chuk Hang Nullah at the southern end of Heung Yip Road (near Aberdeen Police Station); and an area of the Government foreshore and sea-bed at a section of Wong Chuk Hang Nullah at the southeast end of Kwun Hoi Path, as delineated and shown in blue on the Plan numbered SILE/G10/0005/1.	The works involve the construction of two temporary bridges across Wong Chuk Hang Nullah, one from Heung Yip Road and another from Kwun Hoi Path, to the works sites at the south side of the Wong Chuk Hang Nullah for the construction of the South Island Line (East); the works also involve the construction of a footbridge near the outlet of Wong Chuk Hang Nullah.
(c) An area of the Government foreshore and sea-bed of a section of Aberdeen Channel at the southeast side of Ap Lei Chau Bridge Road, as delineated and shown in yellow on the Plans numbered SILE/G10/0005/1 and SILE/G11/0005/1.	The works involve the construction of railway viaduct piers and associated foundations, and the modification of parts of the seawall of the Aberdeen Channel for the railway viaduct of the South Island Line (East).

Statement on Personal Data
