**SOUTH ISLAND LINE (EAST)**

**NOTICE OF ORDER AUTHORIZING  
TEMPORARY CLOSURE OF THE OPEN PLACES ADJACENT TO  
NAM LONG SHAN ROAD SITTING-OUT AREA AND  
AN OPEN PLACE ADJACENT TO KWUN HOI PATH SITTING-OUT AREA**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 7 June 2016 (the 'Order'), authorized:-

- (I) the temporary closure of the open place adjacent to Nam Long Shan Road Sitting-out Area (near Wong Chuk Hang Road), as delineated and shown in orange on the Plan numbered SILE/G09/0011/2;
- (II) the temporary partial closure of the open place adjacent to Nam Long Shan Road Sitting-out Area (near Heung Yip Road), as delineated and shown in green on the Plan numbered SILE/G09/0011/2; and
- (III) the temporary closure of the open place adjacent to Kwun Hoi Path Sitting-out Area, as delineated and shown in yellow on the Plan numbered SILE/G10/0011/2,

during the period from 1 July to 31 December 2016 for the purposes of or incidental to the railway scheme of the South Island Line (East). A description of the works to be carried out, the areas of the open places to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered SILE/G09/0011/2 and SILE/G10/0011/2 (the 'Plans') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:-

A copy of this notice will be affixed on or near the open places affected by the Order on 17 June 2016.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the open places or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the open places affected by the Order.

Notice is hereby given that further closure of the same part or parts of the open places or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
