

**RAILWAYS ORDINANCE (Chapter 519)
(Notice under section 23)**

SOUTH ISLAND LINE (EAST)

**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF PARTS OF HARCOURT GARDEN,
PART OF A FOOTBRIDGE AT HARCOURT GARDEN,
PART OF HONG KONG PARK AND ITS FOOTPATH, AND
SECTIONS OF HARCOURT ROAD, RODNEY STREET, DRAKE STREET,
QUEENSWAY, SUPREME COURT ROAD AND JUSTICE DRIVE**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 11 May 2015 (the 'Order'), authorized:-

- (I) the temporary closure of parts of Harcourt Garden, as delineated and shown in orange on the Plan numbered SILE/G01/0001/5;
- (II) the temporary closure of part of the footbridge at Harcourt Garden connecting United Centre and CITIC Tower, as delineated and shown in purple on the Plan numbered SILE/G01/0001/5;
- (III) the temporary partial closure of the section of Harcourt Road between a point about 120 metres west of its junction with Tim Mei Avenue and a point about 180 metres east of the junction, as delineated and shown in pink on the Plan numbered SILE/G01/0001/5;
- (IV) the temporary partial closure of the section of Rodney Street, the section of Drake Street between its junction with Rodney Street and a point about 90 metres west of the junction, and the section of Queensway between its junction with Tamar Street and a point about 290 metres east of the junction (including the footpath adjacent to the southern side of Harcourt Garden), as delineated and shown in yellow, blue and green respectively on the Plans numbered SILE/G01/0001/5 and SILE/G02/0001/5;
- (V) the temporary closure of part of Hong Kong Park and its footpath, as delineated and shown in purple on the Plan numbered SILE/G02/0001/5; and
- (VI) the temporary partial closure of the section of Supreme Court Road between its junction with Justice Drive and near Queensway Government Offices, and the section of Justice Drive between its junction with Supreme Court Road and a point about 50 metres northeast of the junction, as delineated and shown in pink and orange respectively on the Plan numbered SILE/G02/0001/5,

during the period from 27 May 2015 to 26 May 2016 for the purposes of or incidental to the railway scheme of the South Island Line (East). A description of the works to be carried out, the areas of Harcourt Garden and Hong Kong Park, the footbridge, the footpaths and the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered SILE/G01/0001/5 and SILE/G02/0001/5 (the 'Plans') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

A copy of this notice will be affixed on or near Harcourt Garden, Hong Kong Park, the footbridge, the footpaths and the roads affected by the Order on 15 May 2015.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of Harcourt Garden, Hong Kong Park, the footbridge, the footpaths and the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of Harcourt Garden, Hong Kong Park, the footbridge, the footpaths and the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of Harcourt Garden, Hong Kong Park, the footbridge, the footpaths and the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
