NOTICE OF ORDER AUTHORIZING  
TEMPORARY CLOSURE OF A SECTION OF A FOOTPATH  
NEAR TAI WONG YE TEMPLE AND  
A SECTION OF A FOOTPATH AND STAIRCASE  
NEAR HOLY SPIRIT SEMINARY  
AT WONG CHUK HANG

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 7 June 2011 (the ‘Order’), authorized:—

- (I) the temporary closure of a footpath between its junction with the western end of Tai Wong Ye Temple and a point about 90 metres west of the junction; and
- (II) the temporary closure of a footpath and staircase connecting Holy Spirit Seminary to the southern side of Wong Chuk Hang Nullah,

during the period from 24 June 2011 to 23 June 2012 for the purposes of or incidental to the railway scheme of the South Island Line (East). A description of the works to be carried out and the footpaths and staircase to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plan numbered SILE/G09/0006/1 delineating and showing the footpath affected by (I) in yellow and the Plan numbered SILE/G10/0006/1 delineating and showing the footpath and staircase affected by (II) in red, may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

A copy of this notice will be affixed on or near the footpaths and staircase affected by the Order on 10 June 2011.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 15th Floor, Murray Building, Garden Road, Hong Kong so as to reach the Secretary before the expiration of one

year from the closure of the relevant part or parts of the footpaths and staircase or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the footpaths and staircase affected by the Order.

Notice is hereby given that further closure of the same part or parts of the footpaths and staircase or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

#### SCHEDULE

	<i>Description of the works and the manner in which the footpaths and staircase will be affected</i>
<i>The footpaths and staircase to be affected</i>	
(a) A footpath between its junction with the western end of Tai Wong Ye Temple and a point about 90 metres west of the junction, as delineated and shown in yellow on the Plan numbered SILE/G09/0006/1.	The footpath will be temporarily closed for the modification of parts of Wong Chuk Hang Nullah and the construction of the railway viaduct and the associated railway facilities of the South Island Line (East).
(b) A footpath and staircase connecting Holy Spirit Seminary to the southern side of Wong Chuk Hang Nullah, as delineated and shown in red on the Plan numbered SILE/G10/0006/1.	The footpath and staircase will be temporarily closed for the construction of the railway viaduct and its associated works of the South Island Line (East).

#### Statement on Personal Data
