

**RAILWAYS ORDINANCE (Chapter 519)  
(Notice under section 23)**

**SOUTH ISLAND LINE (EAST)**

**NOTICE OF ORDER AUTHORIZING  
TEMPORARY CLOSURE OF SECTIONS OF SOUTH HORIZON DRIVE,  
YI NAM ROAD AND LEI TUNG ESTATE ROAD**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 30 July 2014 (the ‘Order’), authorized:-

- (I) (a) the temporary partial closure of the section of South Horizon Drive between a point about 20 metres west of its junction with Yi Nam Road and a point about 100 metres west of the junction, as delineated and shown in yellow on the Plan numbered SILE/G13/0007/3, and
- (b) the temporary partial closure of the section of Yi Nam Road between South Horizon Drive and Lee Nam Road, as delineated and shown in green on the Plan numbered SILE/G13/0007/3,

during the period from 27 August 2014 to 30 June 2015; and

- (II) the temporary partial closure of the section of Lei Tung Estate Road adjacent to the Lei Tung Commercial Centre (Phase 1), as delineated and shown in blue on the Plan numbered SILE/G11/0008/3 during the period from 3 September 2014 to 30 June 2015,

for the purposes of or incidental to the railway scheme of the South Island Line (East). A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered SILE/G13/0007/3 and SILE/G11/0008/3 (the ‘Plans’) may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:-

A copy of this notice will be affixed on or near the roads affected by the Order on 8 August 2014.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
