NOTICE OF ORDER AUTHORIZING TEMPORARY CLOSURE OF SECTIONS OF SOUTH HORIZON DRIVE, YI NAM ROAD AND LEI TUNG ESTATE ROAD

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 29 July 2013 (the 'Order'), authorized:-

- (I) (a) the temporary partial closure of the section of South Horizon Drive between a point about 20 metres west of its junction with Yi Nam Road and a point about 100 metres west of the junction, as delineated and shown in yellow on the Plan numbered SILE/G13/0007/2,
 - (b) the temporary partial closure of the section of Yi Nam Road between South Horizon Drive and Lee Nam Road, as delineated and shown in green on the Plan numbered SILE/G13/0007/2.

during the period from 27 August 2013 to 26 August 2014; and

(II) the temporary partial closure of the section of Lei Tung Estate Road adjacent to the Lei Tung Commercial Centre (Phase 1), as delineated and shown in blue on the Plan numbered SILE/G11/0008/2 during the period from 3 September 2013 to 2 September 2014,

for the purposes of or incidental to the railway scheme of the South Island Line (East). A description of the works to be carried out and the areas of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

(a) The section of South Horizon Drive between a point about 20 metres west of its junction with Yi Nam Road and a point about 100 metres west of the junction, as delineated and shown in yellow on the Plan numbered SILE/G13/0007/2. Parts of the carriageway and footpath widths will be temporarily closed for the construction of the station entrance of the railway station at South Horizons and the associated railway facilities of the South Island Line (East).

Description of the works and the manner in which the roads will be affected

- (b) The section of Yi Nam Road between South Horizon Drive and Lee Nam Road, as delineated and shown in green on the Plan numbered SILE/G13/0007/2.
- Parts of the carriageway and footpath widths will be temporarily closed for the construction of the station entrance of the railway station at South Horizons and the associated railway facilities of the South Island Line (East).
- (c) The section of Lei Tung Estate Road adjacent to the Lei Tung Commercial Centre (Phase 1), as delineated and shown in blue on the Plan numbered SILE/G11/0008/2.

Parts of the footpath widths will be temporarily closed for the construction of the station entrance of the railway station at Lei Tung Estate and the associated railway facilities of the South Island Line (East).
