NOTICE OF ORDER AUTHORIZING TEMPORARY CLOSURE OF SECTIONS OF
SOUTH HORIZON DRIVE AND YI NAM ROAD

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Acting Deputy Secretary for Transport and Housing (Transport) has, by order made on 8 August 2011 (the 'Order'), authorized:—

- (I) the temporary partial closure of sections of South Horizon Drive between 20 metres west of its junction with Yi Nam Road and a point about 100 metres west of the junction; and
- (II) the temporary partial closure of sections of Yi Nam Road between South Horizon Drive and Lee Nam Road,

during the period from 27 August 2011 to 26 August 2012 for the purposes of or incidental to the railway scheme of the South Island Line (East). A description of the works to be carried out and the areas of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plan numbered SILE/G13/0007/1 (the 'Plan'), delineating and showing the sections of the roads affected in yellow and green respectively, may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

A copy of this notice will be affixed on or near the roads affected by the Order on 12 August 2011.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing before the expiration of one year from the closure of the relevant part or parts of roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order. Such a written claim should reach the Secretary for Transport and Housing on 15th Floor, Murray Building, Garden Road, Hong Kong on or before 31 December 2011; or the Secretary for

Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Admiralty, Hong Kong on or after 1 January 2012.

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

(a) Sections of South Horizon Drive between 20 metres west of its junction with Yi Nam Road and a point about 100 metres west of the junction, as delineated and shown in yellow on the Plan numbered SILE/G13/0007/1.	Parts of the carriageway and footpath widths will be temporarily closed for the construction of the station entrance of the railway station at South Horizons and the associated railway facilities of the South Island Line (East).
(b) Sections of Yi Nam Road between South Horizon Drive and Lee Nam Road, as delineated and shown in green on the Plan numbered SILE/G13/0007/1.	Parts of the carriageway and footpath widths will be temporarily closed for the construction of the station entrance of the railway station at South Horizons and the associated railway facilities of the South Island Line (East).
