**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF PART OF WONG CHUK HANG ROAD GARDEN,
PARTS OF NAM LONG SHAN ROAD SITTING-OUT AREA AND
PART OF KWUN HOI PATH SITTING-OUT AREA**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 18 December 2015 (the 'Order'), authorized: –

- (I) the temporary closure of part of Wong Chuk Hang Road Garden, as delineated and shown in red on the Plan numbered SILE/G08/0011/1;
- (II) the temporary closure of part of Nam Long Shan Road Sitting-out Area (near Wong Chuk Hang Road), as delineated and shown in orange on the Plan numbered SILE/G09/0011/1;
- (III) the temporary partial closure of part of Nam Long Shan Road Sitting-out Area (near Heung Yip Road), as delineated and shown in brown on the Plan numbered SILE/G09/0011/1; and
- (IV) the temporary closure of part of Kwun Hoi Path Sitting-out Area, as delineated and shown in yellow on the Plan numbered SILE/G10/0011/1,

during the period from 1 January to 31 March 2016 for the purposes of or incidental to the railway scheme of the South Island Line (East). A description of the works to be carried out, the areas of Wong Chuk Hang Road Garden, Nam Long Shan Road Sitting-out Area and Kwun Hoi Path Sitting-out Area to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of Wong Chuk Hang Road Garden, Nam Long Shan Road Sitting-out Area and Kwun Hoi Path Sitting-out Area or the extinction, modification or restriction of his private right in respect of the relevant part or parts of Wong Chuk Hang Road Garden, Nam Long Shan Road Sitting-out Area and Kwun Hoi Path Sitting-out Area affected by the Order.

Notice is hereby given that further closure of the same part or parts of Wong Chuk Hang Road Garden, Nam Long Shan Road Sitting-out Area and Kwun Hoi Path Sitting-out Area or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
