

RAILWAYS ORDINANCE (Chapter 519)
(Order under section 22(1))

SOUTH ISLAND LINE (EAST)

**AUTHORIZATION FOR
TEMPORARY CLOSURE OF SECTIONS OF
OCEAN PARK ROAD, HEUNG YIP ROAD, NAM LONG SHAN ROAD,
SHUM WAN ROAD AND POLICE SCHOOL ROAD**

In exercise of the powers delegated by the Secretary for Transport and Housing, I, by this order made under section 22(1)(a) of the Railways Ordinance (Chapter 519), authorize:—

- (I) (a) the temporary partial closure of sections of Ocean Park Road between the elevated walkway connecting Wong Chuk Hang Recreation Ground and Aberdeen Sports Ground and a point about 100 metres southeast of Aberdeen Sports Ground, as delineated and shown in red on the Plan numbered SILE/G08/0003/7;
- (b) the temporary partial closure of sections of Heung Yip Road between a point about 20 metres southwest of its junction with Nam Long Shan Road and a point about 400 metres northeast of the junction, as delineated and shown in light blue on the Plan numbered SILE/G09/0003/8; and
- (c) the temporary partial closure of sections of Nam Long Shan Road between its junction with Wong Chuk Hang Road and its junction with Heung Yip Road, and sections of Nam Long Shan Road between Nam Long Shan Road Cooked Food Market and a point about 80 metres north of its junction with Welfare Road, as delineated and shown in pink on the Plan numbered SILE/G09/0003/8,

during the period from 1 January to 31 January 2018; and

- (II) (a) the temporary partial closure of the section of Shum Wan Road between its junction with Nam Long Shan Road and a point about 40 metres southwest of the junction, as delineated and shown in green on the Plan numbered SILE/G09/0003/8; and
- (b) the temporary partial closure of sections of Nam Long Shan Road between a point about 80 metres north of its junction with Welfare Road and a point about 110 metres southwest of its junction with Police School Road, and the section of Police School Road between its junction with Nam Long Shan Road and a point about 115 metres northeast of the junction, as delineated and shown in yellow and orange respectively on the Plans numbered SILE/G09/0003/8 and SILE/G16/0003/7,

during the period from 1 January to 8 October 2018.

I further declare under section 22(1)(c) that all public or private rights in, upon, under or over (i) the sections of the roads as described in (I) above during the period from 1 January to 31 January 2018; and (ii) the sections of the roads as described in (II) above during the period from 1 January to 8 October 2018, shall be extinguished, modified or restricted, as the case may be.
