NOTICE OF ORDER AUTHORIZING TEMPORARY CLOSURE OF SECTIONS OF KIANG SU STREET AND LOK SHAN ROAD

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 28 February 2019 (the 'Order'), authorized:-

- (I) the temporary closure of the section of Kiang Su Street between Ma Tau Wai Road and Maidstone Road, as delineated and shown in light pink on the Plan numbered SCL/G24/0055/6; and
- (II) the temporary partial closure of the section of Lok Shan Road between Ma Tau Wai Road and Maidstone Road, as delineated and shown in dark brown on the Plan numbered SCL/G24/0055/6,

during the period from 30 March to 29 June 2019 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing so as to reach the Secretary for Transport and Housing before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order. Claims can be submitted via one of the following means: –
