NOTICE OF ORDER AUTHORIZING TEMPORARY CLOSURE OF SECTIONS OF MA TAU CHUNG ROAD AND SUNG WONG TOI ROAD

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 14 March 2019 (the 'Order'), authorized:-

- (I) the temporary partial closure of the section of Ma Tau Chung Road adjacent to Sung Wong Toi Playground, as delineated and shown in blue on the Plans numbered SCL/G19/0067/1 and SCL/G22/0067/1 during the period from 12 April to 30 June 2019; and
- (II) the temporary partial closure of sections of Sung Wong Toi Road between its junction with Ma Tau Chung Road and a point about 80 metres southeast of the junction, as delineated and shown in yellow on the Plans numbered SCL/G19/0067/1 and SCL/G22/0067/1 during the period from 12 April to 30 September 2019,

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing so as to reach the Secretary for Transport and Housing before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order. Claims can be submitted via one of the following means:-

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

Description of the works and the manner

(b) Sections of Sung Wong Toi Road between its junction with Ma Tau Chung Road and a point about 80 metres southeast of the junction, as delineated and shown in yellow on the Plans numbered SCL/G19/0067/1 and SCL/G22/0067/1. Parts of the footpath widths will be temporarily closed to facilitate the construction of the associated railway facilities of the Shatin to Central Link, and reinstatement works.
