SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF**

**A FOOTPATH BETWEEN CHATHAM ROAD NORTH AND OI SEN PATH;
SLIP ROADS FROM HONG CHONG ROAD TO CHATHAM ROAD NORTH,
FROM WINSLOW STREET TO CHATHAM ROAD NORTH, FROM CHATHAM
ROAD NORTH TO HONG CHONG ROAD AND CHEONG TUNG ROAD SOUTH,
FROM CHATHAM ROAD NORTH TO HONG CHONG ROAD; AND SECTIONS
OF OI SEN PATH, CHATHAM ROAD NORTH AND WINSLOW STREET**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 16 April 2013 (the 'Order'), authorized:-

- (I) the temporary closure of a footpath between Chatham Road North and Oi Sen Path, as delineated and shown in dark green on the Plans numbered SCL/G26/0019/1 and SCL/G27/0019/1;
- (II) the temporary partial closure of slip roads from Hong Chong Road to Chatham Road North, and from Winslow Street to Chatham Road North, as delineated and shown in purple and orange respectively on the Plans numbered SCL/G26/0019/1 and SCL/G27/0019/1;
- (III) the temporary partial closure of slip roads from Chatham Road North to Hong Chong Road and Cheong Tung Road South, and from Chatham Road North to Hong Chong Road, as delineated and shown in yellow and dark blue respectively on the Plan numbered SCL/G27/0019/1;
- (IV) the temporary partial closure of the section of Oi Sen Path between its junction with Winslow Street and a point about 450 metres northwest of the junction, and section of Chatham Road North between its junction with Chatham Road South and a point about 20 metres northeast of its junction with Bulkeley Street, as delineated and shown in green and red respectively on the Plans numbered SCL/G26/0019/1 and SCL/G27/0019/1; and
- (V) the temporary partial closure of the section of Winslow Street between Chatham Road North and Cheong Hang Road, as delineated and shown in blue on the Plan numbered SCL/G27/0019/1,

during the period from 10 May 2013 to 9 May 2014 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out and the footpath, the slip roads and the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered SCL/G26/0019/1 and SCL/G27/0019/1 (the 'Plans') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:-

A copy of this notice will be affixed on or near the footpath, the slip roads and the roads affected by the Order on 26 April 2013.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so

as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the footpath, the slip roads and the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the footpath, the slip roads and the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the footpath, the slip roads and the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

(b) Slip roads from Hong Chong Road to Chatham Road North, and from Winslow Street to Chatham Road North, as delineated and shown in purple and orange respectively on the Plans numbered SCL/G26/0019/1 and SCL/G27/0019/1.	Parts of the carriageway width will be temporarily closed to facilitate the construction of the railway tunnel and the associated railway facilities of the Shatin to Central Link.
(c) Slip roads from Chatham Road North to Hong Chong Road and Cheong Tung Road South, and from Chatham Road North to Hong Chong Road, as delineated and shown in yellow and dark blue respectively on the Plan numbered SCL/G27/0019/1.	Parts of the carriageway width will be temporarily closed to facilitate the construction of the railway tunnel and the associated railway facilities of the Shatin to Central Link.
(d) A section of Oi Sen Path between its junction with Winslow Street and a point about 450 metres northwest of the junction, as delineated and shown in green on the Plans numbered SCL/G26/0019/1 and SCL/G27/0019/1.	Parts of the footpath width will be temporarily closed to facilitate the construction of the railway tunnel and the associated railway facilities of the Shatin to Central Link.
