SHATIN TO CENTRAL LINK

**AUTHORIZATION FOR
TEMPORARY CLOSURE OF SECTIONS OF THE ROAD ADJACENT TO
MTR CHE KUNG TEMPLE STATION, CHE KUNG MIU ROAD AND
SHA TIN TAU ROAD**

In exercise of the powers delegated by the Secretary for Transport and Housing, I, by this order made under section 22(1)(a) of the Railways Ordinance (Chapter 519), authorize:—

- (I) the temporary closure of the section of the road adjacent to MTR Che Kung Temple Station between its two junctions with Che Kung Miu Road, as delineated and shown in pink and red on the Plan numbered SCL/G39/0017/2, with details as follows :
 - (a) from 0.00 a.m. to 5.30 a.m. during the periods of (i) 12 to 17 May 2014, (ii) 19 to 24 May 2014, (iii) 26 to 31 May 2014, (iv) 3 to 7 June 2014, (v) 9 to 14 June 2014, (vi) 16 to 21 June 2014, and (vii) 23 to 28 June 2014, with all carriageways and footpaths of the section of the road closed, as delineated and shown in pink on the Plan numbered SCL/G39/0017/2,
 - (b) from 10 May 2014 to 9 May 2015, except the periods specified in (I)(a) above, with parts of the carriageway and footpath widths of the section of the road closed, as delineated and shown in pink on the Plan numbered SCL/G39/0017/2, and
 - (c) from 10 May 2014 to 9 May 2015, with parts of the carriageway and footpath widths of the section of the road closed, as delineated and shown in red on the Plan numbered SCL/G39/0017/2;
- (II) the temporary partial closure of the section of Che Kung Miu Road between a point about 100 metres west of its junction with Sha Tin Tau Road and a point about 40 metres east of the junction, as delineated and shown in purple on the Plan numbered SCL/G39/0017/2, during the period from 10 May 2014 to 9 May 2015; and
- (III) the temporary partial closure of the section of Sha Tin Tau Road between its junction with Che Kung Miu Road and a point about 30 metres south of the junction, as delineated and shown in green on the Plan numbered SCL/G39/0017/2, during the period from 10 May 2014 to 9 May 2015.

I further declare under section 22(1)(c) that during the period from 10 May 2014 to 9 May 2015, all public or private rights in, upon, under or over the sections of the roads as described above shall be extinguished, modified or restricted, as the case may be.
