TEMPORARY ALTERATION OF SLIP ROADS FROM HONG CHONG ROAD

CHATHAM ROAD NORTH, FROM CHATHAM ROAD NORTH TO
HONG CHONG ROAD AND CHEONG TUNG ROAD SOUTH, AND
FROM CHATHAM ROAD NORTH TO HONG CHONG ROAD,
SECTIONS OF OI SEN PATH AND CHATHAM ROAD NORTH; AND
TEMPORARY CLOSURE OF A FOOTPATH BETWEEN
CHATHAM ROAD NORTH AND OI SEN PATH, AND
SECTIONS OF CHATHAM ROAD NORTH AND WINSLOW STREET

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 17 April 2014 (the 'Order'), authorized:—

- (I) the temporary alteration of the slip roads from Hong Chong Road to Chatham Road North, and from Winslow Street to Chatham Road North, as delineated and shown in purple and orange respectively on the Plans numbered SCL/G26/0019/2 and SCL/G27/0019/2;
- (II) the temporary alteration of the slip roads from Chatham Road North to Hong Chong Road and Cheong Tung Road South, and from Chatham Road North to Hong Chong Road, as delineated and shown in yellow and dark blue respectively on the Plan numbered SCL/G27/0019/2;
- (III) the temporary alteration of the section of Oi Sen Path between its junction with Winslow Street and a point about 450 metres northwest of the junction, as delineated and shown in green on the Plans numbered SCL/G26/0019/2 and SCL/G27/0019/2;
- (IV) the temporary alteration of the section of Chatham Road North between its junction with Chatham Road South and a point about 20 metres northeast of its junction with Bulkeley Street, as delineated and shown in beige on the Plans numbered SCL/G26/0019/2 and SCL/G27/0019/2;
- (V) the temporary closure of the footpath between Chatham Road North and Oi Sen Path, as delineated and shown in dark green on the Plans numbered SCL/G26/0019/2 and SCL/G27/0019/2;

- (VI) the temporary closure of the section of Chatham Road North near its junctions with Winslow Street and Wa Fung Street, as delineated and shown in brown on the Plan numbered SCL/G27/0019/2;
- (VII) the temporary partial closure of the section of Chatham Road North (and its adjacent staircase) between its junctions with Wa Fung Street and Bulkeley Street, as delineated and shown in red on the Plans numbered SCL/G26/0019/2 and SCL/G27/0019/2; and
- (VIII) the temporary partial closure of the section of Winslow Street between Chatham Road North and Lo Lung Hang Street, as delineated and shown in blue on the Plan numbered SCL/G27/0019/2,

during the period from 10 May 2014 to 9 May 2015 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads, footpaths and staircase to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure/alteration of the relevant part or parts of the roads, footpaths and staircase or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads, footpath and staircase affected by the Order.

Notice is hereby given that further closure/alteration of the same part or parts of the roads, footpaths and staircase or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure/alteration will be published if and when such an order is made.

SCHEDULE

The roads, footpaths and staircase to be affected

Description of the works and the manner in which the roads, footpaths and staircase will be affected

- (a) Slip roads from Hong Chong Road to Chatham Road North, and from Winslow Street to Chatham Road North, as delineated and shown in purple and orange respectively on the Plans numbered SCL/G26/0019/2 and SCL/G27/0019/2.
- The carriageways will be temporarily altered with a shift in alignment in close proximity to facilitate the construction of the railway tunnel and the associated railway facilities of the Shatin to Central Link
- (b) Slip roads from Chatham Road North to Hong Chong Road and Cheong Tung Road South, and from Chatham Road North to Hong Chong Road, as delineated and shown in yellow and dark blue respectively on the Plan numbered SCL/G27/0019/2.

The carriageways will be temporarily altered with a shift in alignment in close proximity to facilitate the construction of the railway tunnel and the associated railway facilities of the Shatin to Central Link

The roads, footpaths and staircase to be affected

Description of the works and the manner in which the roads, footpaths and staircase will be affected

(c) The section of Oi Sen Path between its junction with Winslow Street and a point about 450 metres northwest of the junction, as delineated and shown in green on the Plans numbered SCL/G26/0019/2 and SCL/G27/0019/2 The footpath will be temporarily altered with a shift in alignment in close proximity to facilitate the construction of the railway tunnel and the associated railway facilities of the Shatin to Central Link.

(d) The section of Chatham Road North between its junction with Chatham Road South and a point about 20 metres northeast of its junction with Bulkeley Street, as delineated and shown in beige on the Plans numbered SCL/G26/0019/2 and SCL/G27/0019/2. The carriageways will be temporarily altered with a shift in alignment to the adjacent area and parts of the footpath widths will be temporarily closed to facilitate the construction of the railway tunnel and the associated railway facilities of the Shatin to Central Link

(e) The footpath between Chatham Road North and Oi Sen Path, as delineated and shown in dark green on the Plans numbered SCL/G26/0019/2 and SCL/G27/0019/2. The footpath will be temporarily closed to facilitate the construction of the railway tunnel and the associated railway facilities of the Shatin to Central Link.

(f) The section of Chatham Road North near its junctions with Winslow Street and Wa Fung Street, as delineated and shown in brown on the Plan numbered SCL/G27/0019/2. The carriageways and parts of the footpath widths will be temporarily closed to facilitate the construction of the railway tunnel and the associated railway facilities of the Shatin to Central Link

(g) The section of Chatham Road North (and its adjacent staircase) between its junctions with Wa Fung Street and Bulkeley Street, as delineated and shown in red on the Plans numbered SCL/G26/0019/2 and SCL/G27/0019/2. Parts of the staircase, carriageway and footpath widths will be temporarily closed to facilitate the construction of the railway tunnel and the associated railway facilities of the Shatin to Central Link

(h) The section of Winslow Street between Chatham Road North and Lo Lung Hang Street, as delineated and shown in blue on the Plan numbered SCL/G27/0019/2. Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the railway tunnel and the associated railway facilities of the Shatin to Central Link
