

**RAILWAYS ORDINANCE (Chapter 519)
(Notice under section 23)**

SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF SECTIONS OF SAI SHA ROAD;
SLIP ROADS BETWEEN SAI SHA ROAD AND MA ON SHAN BYPASS;
SLIP ROAD FROM SAI SHA ROAD TO LOK WO SHA LANE; AND
A FOOTPATH NEAR MTR WU KAI SHA STATION**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 23 April 2013 (the 'Order'), authorized:-

- (I) the temporary partial closure of a section of Sai Sha Road between the footbridge near MTR Wu Kai Sha Station and a point about 140 metres east of its junction with its slip road to Lok Wo Sha Lane (and its adjacent footpath and cycling track), as delineated and shown in orange on the Plan numbered SCL/G46/0018/1;
- (II) the temporary partial closure of sections of the slip roads between Sai Sha Road and Ma On Shan Bypass, as delineated and shown in yellow on the Plan numbered SCL/G46/0018/1;
- (III) the temporary partial closure of a section of the slip road from Sai Sha Road to Lok Wo Sha Lane, as delineated and shown in blue on the Plan numbered SCL/G46/0018/1; and
- (IV) the temporary closure of a section of the footpath near MTR Wu Kai Sha Station, as delineated and shown in green on the Plan numbered SCL/G46/0018/1,

during the period from 17 May 2013 to 28 February 2014 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads, footpaths and cycling track to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plan numbered SCL/G46/0018/1 (the 'Plan') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:-

A copy of this notice will be affixed on or near the roads and the slope affected by the Order on 3 May 2013.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the roads, the footpaths and the cycling track or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads, the footpaths and the cycling track affected by the Order.

Notice is hereby given that further closure of the same part or parts of the roads, the footpaths and the cycling track or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
