# NOTICE OF ORDER AUTHORIZING TEMPORARY CLOSURE OF SECTIONS OF PAK TAI STREET AND SUNG WONG TOI ROAD

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Logistics has, by order made on 18 April 2023 (the 'Order'), authorized the temporary partial closure of the section of Pak Tai Street between its junction with Sung Wong Toi Road and a point about 90 metres southwest of the junction, and the section of Sung Wong Toi Road near its junction with Pak Tai Street, as delineated and shown in yellow and orange respectively on the Plans numbered SCL/G19/0070/1 and SCL/G22/0070/1 during the period from 15 May 2023 to 14 May 2024 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Logistics so as to reach the Secretary for Transport and Logistics before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order. Claims can be submitted via one of the following means:-

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

### SCHEDULE

The roads to be affected

Description of the works and the manner in which the roads will be affected

The section of Pak Tai Street between its junction with Sung Wong Toi Road and a point about 90 metres southwest of the junction, and the section of Sung Wong Toi Road near its junction with Pak Tai Street, as delineated and shown in yellow and orange respectively on the Plans numbered SCL/G19/0070/1 and SCL/G22/0070/1.

Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the footbridge leading to Sung Wong Toi Station.
