NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF PART OF THE OPEN SPACE AND
THE FOOTBRIDGE IN TSZ WAN SHAN ROAD REST GARDEN;
SECTIONS OF TSZ WAN SHAN ROAD, WAN WAH STREET,
WAI WAH STREET, SHEUNG FUNG STREET, YUK WAH STREET AND
PO KONG VILLAGE ROAD; AND PART OF THE OPEN SPACE IN
TSZ WAN SHAN ESTATE CENTRAL PLAYGROUND

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 23 December 2014 (the 'Order'), authorized:—

- (I) (a) the temporary closure of part of the open space and the footbridge in Tsz Wan Shan Road Rest Garden, as delineated and shown in pink and yellow respectively on the Plan numbered SCL/G10/0009/3;
 - (b) the temporary partial closure of the section of Tsz Wan Shan Road between a point about 60 metres southeast of its junction with Ching Fai Street and a point about 190 metres northwest of the junction, and the section of Tsz Wan Shan Road between its junction with Po Kong Village Road and a point about 130 metres north of the junction, both delineated and shown in orange on the Plan numbered SCL/G10/0009/3; and
 - (c) the temporary partial closure of the section of Wan Wah Street between its junction with Tsz Wan Shan Road and a point about 60 metres south of its junction with Yuk Wah Street, the section of Wai Wah Street between its junction with Wan Wah Street and a point about 30 metres east of the junction, the section of Sheung Fung Street between its junction with Wan Wah Street and a point about 50 metres west of the junction, the section of Yuk Wah Street between its junction with Wan Wah Street and a point about 170 metres east of the junction, and the section of Po Kong Village Road between a point about 60 metres west of its junction with Tsz Wan Shan Road and a point about 30 metres east of the junction, as delineated and shown in dark green, red, purple, beige and light blue respectively on the Plan numbered SCL/G10/0009/3.

during the period from 21 January 2015 to 20 January 2016; and

(II) the temporary closure of part of the open space in Tsz Wan Shan Estate Central Playground, as delineated and shown in dark blue on the Plan numbered SCL/G10/0011/3 during the period from 1 March 2015 to 20 January 2016, for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the open spaces, the footbridge and the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the open spaces, the footbridge and the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the open spaces, the footbridge and the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the open spaces, the footbridge and the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

SCHEDULE

The open spaces, the footbridge and the roads to be affected

Description of the works and the manner in which the open spaces, the footbridge and the roads will be affected

(a) Part of the open space and the footbridge in Tsz Wan Shan Road Rest Garden, as delineated and shown in pink and yellow respectively on the Plan numbered SCL/G10/0009/3. Part of the open space, part of the footbridge deck and the entire footbridge staircase will be temporarily closed to facilitate the construction of the pedestrian walkway system at Yuk Wah Street in relation to the Shatin to Central Link.

(b) The section of Tsz Wan Shan Road between a point about 60 metres southeast of its junction with Ching Fai Street and a point about 190 metres northwest of the junction, and the section of Tsz Wan Shan Road between its junction with Po Kong Village Road and a point about 130 metres north of the junction, both delineated and shown in orange on the Plan numbered SCL/G10/0009/3

Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the pedestrian walkway systems near Tsz Wan Shan Estate Central Playground and at Yuk Wah Street in relation to the Shatin to Central Link

(c) The section of Wan Wah Street between its junction with Tsz Wan Shan Road and a point about 60 metres south of its junction with Yuk Wah Street, as delineated and shown in dark green on the Plan numbered SCL/G10/0009/3. Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the pedestrian walkway systems near Tsz Wan Shan Estate Central Playground and at Yuk Wah Street in relation to the Shatin to Central Link

(d) The section of Wai Wah Street between its junction with Wan Wah Street and a point about 30 metres east of the junction, and the section of Sheung Fung Street between its junction with Wan Wah Street and a point about 50 metres west of the junction, as delineated and shown in red and purple respectively on the Plan numbered SCL/G10/0009/3. Parts of the carriageway and footpath widths will be temporarily closed to faciliate the construction of the pedestrian walkway system near Tsz Wan Shan Estate Central Playground in relation to the Shatin to Central Link.

(e) The section of Yuk Wah Street between its junction with Wan Wah Street and a point about 170 metres east of the junction, and the section of Po Kong Village Road between a point about 60 metres west of its junction with Tsz Wan Shan Road and a point about 30 metres east of the junction, as delineated and shown in beige and light blue respectively on the Plan numbered SCL/G10/0009/3.

Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the pedestrian walkway system at Yuk Wah Street in relation to the Shatin to Central Link

(f) Part of the open space in Tsz Wan Shan Estate Central Playground, as delineated and shown in dark blue on the Plan numbered SCI/G10/0011/3. Part of the open space will be temporarily closed to facilitate the construction of pedestrian walkway system near Tsz Wan Shan Estate Central Playground in relation to the Shatin to Central Link
