

**RAILWAYS ORDINANCE (Chapter 519)
(Notice under section 23)**

SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF SECTIONS OF
OLYMPIC AVENUE AND SUNG WONG TOI ROAD**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 11 January 2013 (the ‘Order’), authorized:-

- (I) the temporary partial closure of the section of Olympic Avenue between Dakota Drive and Hang Wan Road, as delineated and shown in beige on the Plan numbered SCL/G19/0010/1; and
- (II) the temporary partial closure of the section of Sung Wong Toi Road between Hang Wan Road and a point about 60 metres southeast of its junction with Pak Tai Street; and section of Sung Wong Toi Road between Tam Kung Road and a point about 60 metres southeast of its junction with Pak Tai Street, as delineated and shown in yellow on the Plans numbered SCL/G19/0010/1 and SCL/G22/0010/1,

during the period from 1 February 2013 to 31 January 2014 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out and the parts of the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered SCL/G19/0010/1 and SCL/G22/0010/1 (the ‘Plans’) may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:-

A copy of this notice will be affixed on or near the roads affected by the Order on 18 January 2013.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
