

**RAILWAYS ORDINANCE (Chapter 519)  
(Notice under section 23)**

**SHATIN TO CENTRAL LINK**

**NOTICE OF ORDER AUTHORIZING  
TEMPORARY CLOSURE OF SECTIONS OF  
OLYMPIC AVENUE, SUNG WONG TOI ROAD, NAM KOK ROAD,  
NGA TSIN WAI ROAD AND PRINCE EDWARD ROAD WEST**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 14 January 2014 (the 'Order'), authorized:-

- (I) (a) the temporary partial closure of the section of Olympic Avenue between Dakota Drive and Hang Wan Road, as delineated and shown in beige on the Plans numbered SCL/G19/0010/2 and SCL/G22/0010/2, and
- (b) the temporary partial closure of the sections of Sung Wong Toi Road between Hang Wan Road and a point about 60 metres southeast of its junction with Pak Tai Street, and between Tam Kung Road and a point about 60 metres southeast of its junction with Pak Tai Street, as delineated and shown in yellow on the Plans numbered SCL/G19/0010/2 and SCL/G22/0010/2,

during the period from 1 February 2014 to 31 January 2015; and

- (II) (a) the temporary partial closure of the section of Nam Kok Road between Prince Edward Road West and a point about 50 metres north of its junction with Nga Tsin Wai Road, as delineated and shown in red on the Plans numbered SCL/G18/0013/2 and SCL/G21/0013/2,
- (b) the temporary partial closure of the section of Nga Tsin Wai Road between Lung Kong Road and Nga Tsin Long Road, as delineated and shown in orange on the Plans numbered SCL/G18/0013/2 and SCL/G21/0013/2, and
- (c) the temporary partial closure of the section of Prince Edward Road West between a point about 5 metres east of its junction with Nam Kok Road and a point about 20 metres west of the junction, as delineated and shown in pink on the Plans numbered SCL/G18/0013/2 and SCL/G21/0013/2,

during the period from 15 March 2014 to 14 March 2015,

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered SCL/G18/0013/2, SCL/G19/0010/2, SCL/G21/0013/2 and SCL/G22/0010/2 (the 'Plans') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:-

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
