## SHATIN TO CENTRAL LINK

## NOTICE OF ORDER AUTHORIZING TEMPORARY CLOSURE OF SECTIONS OF PRINCESS MARGARET ROAD LINK

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 30 June 2016 (the 'Order'), authorized:—

- (I) the temporary closure of the section of Princess Margaret Road Link between its junction with Chi Man Street and Cheong Wan Road, the section of Princess Margaret Road Link between Hung Ling Street and Hung Lai Road, and the section of Princess Margaret Road Link between its junction with the slip road from Chatham Road North to Hong Chong Road and a point about 140 metres southeast of the junction, as delineated and shown in pink on the Plans numbered SCL/G26/0057/1 and SCL/G27/0057/1, with details as follows:
  - (a) from 1:30 a.m. to 5:30 a.m. on not more than 4 Sundays during the period of 17 July to 11 September 2016, with all carriageway widths of the sections of the road temporarily closed; and
  - (b) during the period of 15 July to 16 December 2016, except the period specified in (I)(a) above, with parts of the carriageway widths of the sections of the road temporarily closed; and
- (II) the temporary closure of the section of Princess Margaret Road Link between Hung Lai Road and Hung Ling Street, the section of Princess Margaret Road Link between Cheong Wan Road and its junction with the slip road from Hong Chong Road to Princess Margaret Road, and the section of Princess Margaret Road Link between its junction with Chatham Road South and a point about 220 metres northeast of the junction, as delineated and shown in yellow on the Plan numbered SCL/G27/0057/1, with details as follows:
  - (a) from 1:30 a.m. to 5:30 a.m. on not more than 4 Sundays during the period of 17 July to 11 September 2016, with all carriageway widths of the sections of the road temporarily closed; and
  - (b) during the period of 15 July 2016 to 27 January 2017, except the period specified in (II)(a) above, with parts of the carriageway widths of the sections of the road temporarily closed,

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the road to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the road or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the road affected by the Order.

Notice is hereby given that further closure of the same part or parts of the road or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

Description of the works and the manner in which the road will be affected

- (a) The section of Princess Margaret Road Link between its junction with Chi Man Street and Cheong Wan Road, the section of Princess Margaret Road Link between Hung Ling Street and Hung Lai Road, and the section of Princess Margaret Road Link between its iunction with the slip road from Chatham Road North to Hong Chong Road and a point about 140 metres southeast of the junction, as delineated and shown in pink on the Plans SCL/G26/0057/1 numbered and SCL/G27/0057/1
- From 1:30 a.m. to 5:30 a.m. on not more than 4 Sundays during the period of 17 July to 11 September 2016, all carriageway widths will be temporarily closed to facilitate the bridge bearing replacement works at Princess Margaret Road Link in relation to the Shatin to Central Link.

(b) The section of Princess Margaret Road
Link between Hung Lai Road and Hung
Ling Street, the section of Princess
Margaret Road Link between Cheong
Wan Road and its junction with the slip
road from Hong Chong Road to
Princess Margaret Road, and the section
of Princess Margaret Road Link
between its junction with Chatham
Road South and a point about 220

metres northeast of the junction, as

delineated and shown in yellow on the

Plan numbered SCL/G27/0057/1.

During the period of 15 July to 16 December 2016, except the period specified above, parts of the carriageway widths will be temporarily closed to facilitate the parapet modification works at Princess Margaret Road Link in relation to the Shatin to Central Link.

From 1:30 a.m. to 5:30 a.m. on not more than 4 Sundays, except for those closure Sundays mentioned in sub-paragraph (a) above, during the period of 17 July to 11 September 2016, all carriageway widths will be temporarily closed to facilitate the bridge bearing replacement works at Princess Margaret Road Link in relation to the Shatin to Central Link.

During the period of 15 July 2016 to 27 January 2017, except the period specified above, parts of the carriageway widths will be temporarily closed to facilitate the parapet modification works at Princess Margaret Road Link in relation to the Shatin to Central Link
