**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF
PART OF SUNG WONG TOI PLAYGROUND, AND OLYMPIC GARDEN**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 1 June 2018 (the 'Order'), authorized:—

- (I) the temporary closure of part of Sung Wong Toi Playground, as delineated and shown in red on the Plans numbered SCL/G19/0042/5 and SCL/G22/0042/5; and
- (II) the temporary partial closure of Olympic Garden, as delineated and shown in green on the Plans numbered SCL/G19/0042/5 and SCL/G22/0042/5,

during the period from 1 July to 30 December 2018 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the area of part of Sung Wong Toi Playground and Olympic Garden to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered SCL/G19/0042/5 and SCL/G22/0042/5 (the 'Plans') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

A copy of this notice will be affixed on or near Sung Wong Toi Playground and Olympic Garden affected by the Order on 8 June 2018.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing so as to reach the Secretary for Transport and Housing before the expiration of one year from the closure of the relevant part or parts of Sung Wong Toi Playground and Olympic Garden or the extinction, modification or restriction of his private right in respect of the relevant part or parts of Sung Wong Toi Playground and Olympic Garden affected by the Order. Claims can be submitted via one of the following means:-

- (1) by post or by hand to the Transport and Housing Bureau's Drop-in Box No. 6 located at the 2nd Floor Entrance, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong. The box is available for use between 8:00 a.m. and 7:00 p.m. from Monday to Friday (except public holidays);

Notice is hereby given that further closure of the same part or parts of Sung Wong Toi Playground and Olympic Garden or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

- (b) Olympic Garden, as delineated and shown in green on the Plans numbered SCL/G19/0042/5 and SCL/G22/0042/5. Parts of Olympic Garden will be temporarily closed to facilitate the construction of the associated railway facilities of the Shatin to Central Link, and reinstatement works.
