**SHATIN TO CENTRAL LINK**

**NOTICE OF ORDER AUTHORIZING  
TEMPORARY CLOSURE OF LOK SHAN ROAD PLAYGROUND,  
MA TAU WAI ROAD/TO KWA WAN ROAD GARDEN AND  
MA TAU WAI ROAD/TO KWA WAN ROAD AMENITY PLOT, AND  
PART OF TO KWA WAN COMPLEX PLAYGROUND; AND THE WORKS  
OVER AND UPON THE GOVERNMENT FORESHORE AND SEA-BED AT  
KOWLOON BAY OFF THE FORMER KAI TAK AIRPORT RUNWAY**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 15 July 2016 (the 'Order'), authorized:-

- (I) the temporary closure of Lok Shan Road Playground, Ma Tau Wai Road/To Kwa Wan Road Garden and Ma Tau Wai Road/To Kwa Wan Road Amenity Plot, as delineated and shown in red, dark blue and dark green respectively on the Plan numbered SCL/G24/0002/4;
- (II) the temporary closure of part of To Kwa Wan Complex Playground, as delineated and shown in yellow on the Plan numbered SCL/G24/0002/4; and
- (III) the works over and upon the Government foreshore and sea-bed at Kowloon Bay off the former Kai Tak Airport runway, as delineated and shown in red on the Plan numbered SCL/G17/0001/2,

during the period from 13 August 2016 to 12 August 2017 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the areas of Lok Shan Road Playground, Ma Tau Wai Road/To Kwa Wan Road Garden, Ma Tau Wai Road/To Kwa Wan Road Amenity Plot, To Kwa Wan Complex Playground and the Government foreshore and sea-bed to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of Lok Shan Road Playground, Ma Tau Wai Road/To Kwa Wan Road Garden, Ma Tau Wai Road/To Kwa Wan Road Amenity Plot and To Kwa Wan Complex Playground or the date of extinction, modification or restriction of his private right in respect of the relevant part or parts of Lok Shan Road Playground, Ma Tau Wai Road/To Kwa Wan Road Garden, Ma Tau Wai Road/To Kwa Wan Road Amenity Plot, To Kwa Wan Complex Playground and the Government foreshore and sea-bed affected by the Order.

Notice is hereby given that further closure of the same part or parts of Lok Shan Road Playground, Ma Tau Wai Road/To Kwa Wan Road Garden, Ma Tau Wai Road/To Kwa Wan Road Amenity Plot and To Kwa Wan Complex Playground and further works over and upon the same part or parts of the Government foreshore and sea-bed or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure and works will be published if and when such an order is made.
