NOTICE OF ORDER AUTHORIZING
THE WORKS OVER AND UPON
THE GOVERNMENT FORESHORE AND SEA-BED AT KOWLOON BAY OFF
THE FORMER KAI TAK AIRPORT RUNWAY; AND
TEMPORARY CLOSURE OF
THE OPEN SPACES IN LOK SHAN ROAD PLAYGROUND,
MA TAU WAI ROAD/TO KWA WAN ROAD GARDEN AND
MA TAU WAI ROAD/TO KWA WAN ROAD AMENITY PLOT, AND
PART OF THE OPEN SPACE IN TO KWA WAN COMPLEX PLAYGROUND

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 21 July 2014 (the 'Order'), authorized:—

- the works over and upon the Government foreshore and sea-bed at Kowloon Bay off the former Kai Tak Airport runway, as delineated and shown in red on the Plan numbered SCL/G17/0001/1;
- (II) the temporary closure of the open spaces in Lok Shan Road Playground, Ma Tau Wai Road/To Kwa Wan Road Garden and Ma Tau Wai Road/To Kwa Wan Road Amenity Plot, as delineated and shown in red, dark blue and dark green respectively on the Plan numbered SCL/G24/0002/2; and
- (III) the temporary closure of part of the open space in To Kwa Wan Complex Playground, as delineated and shown in yellow on the Plan numbered SCL/G24/0002/2,

during the period from 13 August 2014 to 12 August 2015 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the Government foreshore and sea-bed and the open spaces to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the date of extinction, modification or restriction of his private right in respect of the relevant part or parts of the Government foreshore and sea-bed and the open spaces affected by the Order.

Notice is hereby given that further works over and upon the same part or parts of the Government foreshore and sea-bed and further closure of the same part or parts of the open spaces or any of such part or parts may be required upon expiration of the Order. Details of any further order for works and closure will be published if and when such an order is made.

## **SCHEDULE**

The Government foreshore and sea-bed and the open spaces to be affected

Description of the works and the manner in which the Government foreshore and sea-bed and the open spaces will be affected

(a) An area of Kowloon Bay off the former Kai Tak Airport runway at its western side, as delineated and shown in red on the Plan numbered SCI/G17/0001/1. The works involve operation of temporary barge loading/unloading facilities and temporary barge mooring area, where parts of the facilities will be extended to over and upon the foreshore and sea-bed (above sea level) to facilitate the construction of the Shatin to Central Link.

(b) The open space in Lok Shan Road Playground, as delineated and shown in red on the Plan numbered SCL/G24/0002/2.

The open space will be temporarily closed to facilitate the construction of the entrance of the railway station at Ma Tau Wai and the associated railway facilities of the Shatin to Central Link.

(c) The open spaces in Ma Tau Wai Road/To Kwa Wan Road Garden and Ma Tau Wai Road/To Kwa Wan Road Amenity Plot, as delineated and shown in dark blue and dark green respectively on the Plan numbered SCL/G24/0002/2. The open spaces will be temporarily closed to facilitate the construction of the railway station at Ma Tau Wai and the associated railway facilities of the Shatin to Central Link.

(d) Part of the open space in To Kwa Wan Complex Playground, as delineated and shown in yellow on the Plan numbered SCL/G24/0002/2. Part of the open space will be temporarily closed to facilitate the construction of the railway station at Ma Tau Wai and the associated railway facilities of the Shatin to Central Link.

## Statement on Personal Data
