

**RAILWAYS ORDINANCE (Chapter 519)
(Notice under section 23)**

SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF SECTIONS OF
OLYMPIC AVENUE, SUNG WONG TOI ROAD, NAM KOK ROAD,
NGA TSIN WAI ROAD AND PRINCE EDWARD ROAD WEST**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 13 January 2015 (the 'Order'), authorized:-

- (I) (a) the temporary partial closure of the section of Olympic Avenue between Dakota Drive and Hang Wan Road, as delineated and shown in beige on the Plans numbered SCL/G19/0010/3 and SCL/G22/0010/3, and
- (b) the temporary partial closure of the section of Sung Wong Toi Road between Hang Wan Road and a point about 60 metres southeast of its junction with Pak Tai Street, and the section of Sung Wong Toi Road between Ma Tau Chung Road and a point about 60 metres southeast of its junction with Pak Tai Street, as delineated and shown in yellow on the Plans numbered SCL/G19/0010/3 and SCL/G22/0010/3,

during the period from 1 February 2015 to 31 January 2016; and

- (II) the temporary partial closure of the section of Nam Kok Road between Prince Edward Road West and a point about 50 metres north of its junction with Nga Tsin Wai Road, the section of Nga Tsin Wai Road between Lung Kong Road and Nga Tsin Long Road, and the section of Prince Edward Road West between a point about 5 metres east of its junction with Nam Kok Road and a point about 20 metres west of the junction, as delineated and shown in red, orange and pink respectively on the Plans numbered SCL/G18/0013/3 and SCL/G21/0013/3 during the period from 15 March 2015 to 31 January 2016,

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered SCL/G18/0013/3, SCL/G19/0010/3, SCL/G21/0013/3 and SCL/G22/0010/3 (the 'Plans') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:-

A copy of this notice will be affixed on or near the roads affected by the Order on 16 January 2015.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

(a) The section of Olympic Avenue between Dakota Drive and Hang Wan Road, as delineated and shown in beige on the Plans numbered SCL/G19/0010/3 and SCL/G22/0010/3.	Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the railway station, railway tunnel at To Kwa Wan and the associated railway facilities of the Shatin to Central Link.
(b) The section of Sung Wong Toi Road between Hang Wan Road and a point about 60 metres southeast of its junction with Pak Tai Street, and the section of Sung Wong Toi Road between Ma Tau Chung Road and a point about 60 metres southeast of its junction with Pak Tai Street, as delineated and shown in yellow on the Plans numbered SCL/G19/0010/3 and SCL/G22/0010/3.	Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the railway station, railway tunnel at To Kwa Wan and the associated railway facilities of the Shatin to Central Link.
(c) The section of Nam Kok Road between Prince Edward Road West and a point about 50 metres north of its junction with Nga Tsin Wai Road, the section of Nga Tsin Wai Road between Lung Kong Road and Nga Tsin Long Road, and the section of Prince Edward Road West between a point about 5 metres east of its junction with Nam Kok Road and a point about 20 metres west of the junction, as delineated and shown in red, orange and pink respectively on the Plans numbered SCL/G18/0013/3 and SCL/G21/0013/3.	Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the railway station at To Kwa Wan and the associated railway facilities of the Shatin to Central Link.
