

**RAILWAYS ORDINANCE (Chapter 519)
(Notice under section 23)**

SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF
THE OPEN SPACES IN LOK SHAN ROAD PLAYGROUND,
MA TAU WAI ROAD/TO KWA WAN ROAD GARDEN AND
MA TAU WAI ROAD/TO KWA WAN ROAD AMENITY PLOT; AND
PARTS OF THE OPEN SPACE IN TO KWA WAN COMPLEX PLAYGROUND**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 20 July 2012 (the ‘Order’), authorized:–

- (I) the temporary closure of the open spaces in Lok Shan Road Playground, Ma Tau Wai Road/To Kwa Wan Road Garden and Ma Tau Wai Road/To Kwa Wan Road Amenity Plot, as delineated and shown in red, dark blue and dark green respectively on Plan numbered SCL/G24/0002/1; and
- (II) the temporary closure of parts of the open space in To Kwa Wan Complex Playground, as delineated and shown in yellow on Plan numbered SCL/G24/0002/1,

during the period from 13 August 2012 to 12 August 2013 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the open spaces to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plan numbered SCL/G24/0002/1 (the ‘Plan’) may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:–

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22/F, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the open spaces or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the open spaces affected by the Order.

Notice is hereby given that further closure of the same part or parts of the open spaces or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

(a) The open space in Lok Shan Road Playground, as delineated and shown in red on the Plan numbered SCL/G24/0002/1.	The open space will be temporarily closed in connection with the construction of the station entrance of the railway station at Ma Tau Wai and the associated railway facilities of the Shatin to Central Link.
(b) The open spaces in Ma Tau Wai Road/To Kwa Wan Road Garden and Ma Tau Wai Road/To Kwa Wan Road Amenity Plot, as delineated and shown in dark blue and dark green respectively on the Plan numbered SCL/G24/0002/1.	The open spaces will be temporarily closed in connection with the construction of the railway station at Ma Tau Wai and the associated railway facilities of the Shatin to Central Link.
(c) Parts of the open space in To Kwa Wan Complex Playground, as delineated and shown in yellow on the Plan numbered SCL/G24/0002/1.	Parts of the open space will be temporarily closed in connection with the construction of the railway station at Ma Tau Wai and the associated railway facilities of the Shatin to Central Link.

Statement on Personal Data
