**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF A SECTION OF MA CHAI HANG ROAD, AND
PART OF MA CHAI HANG RECREATION GROUND**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 9 September 2019 (the 'Order'), authorized:—

- (I) the temporary partial closure of the section of Ma Chai Hang Road between a point about 10 metres south of its junction with Chuk Yuen Road and a point about 160 metres southeast of the junction, as delineated and shown in yellow on the Plan numbered SCL/G07/0012/7; and
- (II) the temporary closure of part of Ma Chai Hang Recreation Ground, as delineated and shown in green on the Plan numbered SCL/G07/0012/7,

during the period from 1 October 2019 to 30 September 2020 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the section of the road and the area of Ma Chai Hang Recreation Ground to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plan numbered SCL/G07/0012/7 (the 'Plan') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

A copy of this notice will be affixed on or near the road and Ma Chai Hang Recreation Ground affected by the Order on 13 September 2019.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing so as to reach the Secretary for Transport and Housing before the expiration of one year from the closure of the relevant part or parts of the road and Ma Chai Hang Recreation Ground or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the road and Ma Chai Hang Recreation Ground affected by the Order. Claims can be submitted via one of the following means:-

- (1) by post or by hand to the Transport and Housing Bureau's Drop-in Box No. 6 located at the 2nd Floor Entrance, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong. The box is available for use between 8:00 a.m. and 7:00 p.m. from Monday to Friday (except public holidays);

Notice is hereby given that further closure of the same part or parts of the road and Ma Chai Hang Recreation Ground or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
