NOTICE OF ORDER AUTHORIZING TEMPORARY CLOSURE OF SECTIONS OF SHA KOK STREET, SHUI CHUEN AU STREET AND YAT TAI STREET

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 23 September 2013 (the 'Order'), authorized:-

- (I) the temporary partial closure of the section of Sha Kok Street between a point about 90 metres northeast of its junction with Yat Tai Street and a point about 280 metres northeast of the junction, and the section of Shui Chuen Au Street between a point about 60 metres northwest of its junction with Yat Tai Street and a point about 30 metres southeast of the junction, as delineated and shown in red and blue respectively on the Plan numbered SCL/G40/0026/1 during the period from 11 October 2013 to 10 October 2014; and
- (II) the temporary closure of the section of Yat Tai Street between its junction with Shui Chuen Au Street and a point about 130 metres southwest of the junction, as delineated and shown in green on the Plan numbered SCL/G40/0026/1:
 - (a) from 11.45 p.m. to 5.00 a.m. (excluding Sundays) during the periods of
 (i) 11 to 12 October 2013, (ii) 15 to 19 October 2013, (iii) 21 to 26
 October 2013, (iv) 4 to 8 February 2014, (v) 10 to 15 February 2014, (vi) 17 to 22 March 2014, (vii) 24 to 29 March 2014, (viii) 31 March to 4
 April 2014, and (ix) 7 to 12 April 2014, with all carriageways and parts of the footpath widths of the section of the road closed; and
 - (b) from 11 October 2013 to 10 October 2014, except the periods specified in (II)(a) above, with parts of the carriageway and footpath widths of the section of the road closed,

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

SCHEDULE

The roads to be affected

- (a) The section of Sha Kok Street between a point about 90 metres northeast of its junction with Yat Tai Street and a point about 280 metres northeast of the junction, and the section of Shui Chuen Au Street between a point about 60 metres northwest of its junction with Yat Tai Street and a point about 30 metres southeast of the junction, as delineated and shown in red and blue respectively on the Plan.
- (b) The section of Yat Tai Street between its junction with Shui Chuen Au Street and a point about 130 metres southwest of the junction, as delineated and shown in green on the Plan.

Description of the works and the manner in which the roads will be affected

Parts of the carriageway and footpath widths will be temporarily closed to facilitate the modification works of the MTR Sha Tin Wai Station in relation to the Shatin to Central Link.

From 11.45 p.m. to 5.00 a.m. (excluding Sundays) during the periods of (i) 11 to 12 October 2013, (ii) 15 to 19 October 2013, (iii) 21 to 26 October 2013, (iv) 4 to 8 February 2014, (v) 10 to 15 February 2014, (vi) 17 to 22 March 2014, (vii) 24 to 29 March 2014, (viii) 31 March to 4 April 2014, and (ix) 7 to 12 April 2014, all carriageways and parts of the footpath widths will be temporarily closed to facilitate the modification works of the MTR Sha Tin Wai Station in relation to the Shatin to Central Link.

Except the periods specified above, parts of the carriageway and footpath widths will be temporarily closed to facilitate the modification works of the MTR Sha Tin Wai Station in relation to the Shatin to Central Link.

Statement on Personal Data

Any information, including the personal data, submitted to the Secretary for Transport and Housing in connection with any written claims as required under section 34 of the Railways Ordinance (Chapter 519) will be used for the processing of the claims and other related purposes.
