NOTICE OF ORDER AUTHORIZING TEMPORARY CLOSURE OF A SECTION OF MA ON SHAN ROAD

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 18 October 2013 (the 'Order') authorized the temporary partial closure of a section of Ma On Shan Road southbound of about 265 metres long (adjacent to MTR Tai Shui Hang Station) during the period from 8 November 2013 to 7 November 2014 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the section of the road to be affected and the manner in which it will be affected is given in the Schedule below.

Notice is hereby given that further closure of the same part or parts of the road or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
