SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
 TEMPORARY CLOSURE OF A SECTION OF NGA TSIN WAI ROAD, AND
 A PEDESTRIAN SUBWAY CONNECTING OLYMPIC GARDEN AND
 PRINCE EDWARD ROAD WEST; AND TEMPORARY ALTERATION OF
 A SECTION OF PRINCE EDWARD ROAD WEST**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 1 December 2016 (the 'Order'), authorized:-

- (I) the temporary partial closure of the section of Nga Tsin Wai Road between a point about 10 metres east of its junction with Nam Kok Road and a point about 100 metres west of the junction, as delineated and shown in orange on the Plans numbered SCL/G18/0042/1 and SCL/G21/0042/1;
- (II) the temporary partial closure of the pedestrian subway connecting Olympic Garden and Prince Edward Road West, as delineated and shown in yellow on the Plans numbered SCL/G18/0042/1, SCL/G19/0042/3, SCL/G21/0042/1 and SCL/G22/0042/3; and
- (III) the temporary alteration of the section of Prince Edward Road West between its junctions with Hau Wong Road and South Wall Road, as delineated and shown in pink on the Plans numbered SCL/G18/0042/1, SCL/G19/0042/3, SCL/G21/0042/1 and SCL/G22/0042/3,

during the period from 31 December 2016 to 30 December 2017, for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads and the pedestrian subway to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered SCL/G18/0042/1, SCL/G19/0042/3, SCL/G21/0042/1 and SCL/G22/0042/3 (the 'Plans') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:-

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure/alteration of the relevant part or parts of the roads and the pedestrian subway or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads and the pedestrian subway affected by the Order.

Notice is hereby given that further closure/alteration of the same part or parts of the roads and the pedestrian subway or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure/alteration will be published if and when such an order is made.

- The carriageway will be temporarily altered with a shift in alignment in close proximity and part of the footpath widths will be temporarily closed to facilitate the construction of the railway station, railway tunnel and the associated railway facilities of the Shatin to Central Link.
