NOTICE OF ORDER AUTHORIZING TEMPORARY CLOSURE OF A SECTION OF CHOI HUNG ROAD

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 8 September 2015 (the 'Order'), authorized the temporary partial closure of the section of Choi Hung Road between a point about 60 metres southeast of its junction with Sze Mei Street and a point about 320 metres southeast of the junction, as delineated and shown in red on the Plans numbered SCL/G11/0025/3, SCL/G12/0025/2 and SCL/G13/0025/3, during the period from 3 October 2015 to 2 October 2016 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the section of the road to be affected and the manner in which it will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the road or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the road affected by the Order.

Notice is hereby given that further closure of the same part or parts of the road or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

SCHEDULE

The road to be affected

The section of Choi Hung Road between a point about 60 metres southeast of its junction with Sze Mei Street and a point about 320 metres southeast of the junction, as delineated and shown in red on the Plans numbered SCL/G11/0025/3, SCL/G12/0025/2 and SCL/G13/0025/3.

Description of the works and the manner in which the road will be affected

Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the railway tunnel and the associated railway facilities of the Shatin to Central Link.
