

**RAILWAYS ORDINANCE (Chapter 519)
(Notice under section 23)**

SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF SECTIONS OF FUNG TAK ROAD,
LUNG POON STREET, YUK WAH STREET, YUK WAH CRESCENT;
A SECTION OF THE ACCESS ROAD CONNECTING WONG TAI SIN ROAD
AND SIK SIK YUEN WONG TAI SIN TEMPLE; AND
SECTIONS OF MA CHAI HANG ROAD, NGA CHUK STREET,
WONG TAI SIN ROAD, SHATIN PASS ROAD,
YING FUNG LANE AND FUNG TAK ROAD**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 2 December 2013 (the ‘Order’), authorized:—

- (I) (a) the temporary partial closure of the section of Fung Tak Road between a point about 50 metres southeast of its junction with Lung Poon Street and a point about 50 metres northwest of the junction, and the section of Lung Poon Street between its junction with Fung Tak Road and a point about 140 metres southwest of the junction, as delineated and shown in pink and blue respectively on the Plan numbered SCL/G09/0007/2; and
- (b) the temporary partial closure of the section of Yuk Wah Street between its junction with Tsz Wan Shan Road and a point about 280 metres west of the junction, and the section of Yuk Wah Crescent (near Manning Theatre Building) between its junction with Yuk Wah Street and a point about 14 metres south of the junction, as delineated and shown in green and yellow respectively on the Plan numbered SCL/G10/0007/2,
- during the period from 21 December 2013 to 20 December 2014; and
- (II) (a) the temporary partial closure of the section of the access road connecting Wong Tai Sin Road and Sik Sik Yuen Wong Tai Sin Temple between its junction with Wong Tai Sin Road and a point about 40 metres southwest of the junction, as delineated and shown in pink on the Plan numbered SCL/G08/0008/2;
- (b) the temporary partial closure of the section of Ma Chai Hang Road between its junction with Wong Tai Sin Road and a point about 90 metres west of the junction, as delineated and shown in orange on the Plans numbered SCL/G07/0008/2 and SCL/G08/0008/2;

- (c) the temporary partial closure of the section of Nga Chuk Street near its junction with Wong Tai Sin Road, as delineated and shown in purple on the Plan numbered SCL/G08/0008/2;
- (d) the temporary partial closure of the section of Wong Tai Sin Road between Ma Chai Hang Road and Shatin Pass Road, as delineated and shown in green on the Plans numbered SCL/G07/0008/2 and SCL/G08/0008/2;
- (e) the temporary partial closure of the section of Shatin Pass Road between a point about 65 metres north of its junction with Fung Tak Road and a point about 50 metres southwest of the junction, as delineated and shown in blue on the Plan numbered SCL/G08/0008/2;
- (f) the temporary partial closure of the section of Ying Fung Lane between its junction with Fung Tak Road and a point about 20 metres south of the junction, as delineated and shown in brown on the Plan numbered SCL/G08/0008/2; and
- (g) the temporary partial closure of the section of Fung Tak Road between its junction with Shatin Pass Road and a point about 50 metres east of the junction, as delineated and shown in yellow on the Plan numbered SCL/G08/0008/2,

during the period from 1 January to 31 December 2014,

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered SCL/G07/0008/2, SCL/G08/0008/2, SCL/G09/0007/2 and SCL/G10/0007/2 (the 'Plans') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
