

**RAILWAYS ORDINANCE (Chapter 519)
(Notice under section 23)**

SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF
SECTIONS OF CHAP WAI KON STREET AND NGAN SHING STREET**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 10 December 2013 (the 'Order'), authorized:—

- (I) the temporary partial closure of the section of Chap Wai Kon Street (and its adjacent footpath, cycling track and bicycle parking area) between a point about 40 metres southwest of its junction with Ngan Shing Street and a point about 300 metres northeast of the junction, as delineated and shown in yellow on the Plan numbered SCL/G41/0030/1; and
- (II) the temporary partial closure of the section of Ngan Shing Street (and its adjacent footpath and cycling track) between a point about 60 metres northwest of its junction with Chap Wai Kon Street and a point about 75 metres southeast of the junction, as delineated and shown in green on the Plan numbered SCL/G41/0030/1,

during the period from 1 January to 31 December 2014 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plan numbered SCL/G41/0030/1 (the 'Plan') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
