

**RAILWAYS ORDINANCE (Chapter 519)
(Notice under section 23)**

SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF
SECTIONS OF FUNG TAK ROAD, LUNG POON STREET,
YUK WAH STREET AND YUK WAH CRESCENT**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 26 November 2012 (the 'Order'), authorized:—

- (I) the temporary partial closure of sections of Fung Tak Road between a point about 50 metres southeast of its junction with Lung Poon Street and a point about 50 metres northwest of the junction, and sections of Lung Poon Street between its junction with Fung Tak Road and a point about 140 metres southwest of the junction, as delineated and shown in pink and blue respectively on the Plan numbered SCL/G09/0007/1; and
- (II) the temporary partial closure of sections of Yuk Wah Street between its junction with Tsz Wan Shan Road and a point about 280 metres west of the junction, and sections of Yuk Wah Crescent (near Manning Theatre Building) between its junction with Yuk Wah Street and a point about 14 metres south of the junction, as delineated and shown in green and yellow respectively on the Plan numbered SCL/G10/0007/1,

during the period from 21 December 2012 to 20 December 2013 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the areas of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered SCL/G09/0007/1 and SCL/G10/0007/1 (the 'Plans') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

A copy of this notice will be affixed on or near the roads affected by the Order on 7 December 2012.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

<i>The roads to be affected</i>	<i>Description of the works and the manner in which the roads will be affected</i>
(a) Sections of Fung Tak Road between a point about 50 metres southeast of its junction with Lung Poon Street and a point about 50 metres northwest of the junction, and sections of Lung Poon Street between its junction with Fung Tak Road and a point about 140 metres southwest of the junction, as delineated and shown in pink and blue respectively on the Plan numbered SCL/G09/0007/1.	Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the pedestrian walkway system at Fung Tak in relation to the Shatin to Central Link.
(b) Sections of Yuk Wah Street between its junction with Tsz Wan Shan Road and a point about 280 metres west of the junction, as delineated and shown in green on the Plan numbered SCL/G10/0007/1.	Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of the pedestrian walkway system at Yuk Wah Street in relation to the Shatin to Central Link.
(c) Sections of Yuk Wah Crescent (near Manning Theatre Building) between its junction with Yuk Wah Street and a point about 14 metres south of the junction, as delineated and shown in yellow on the Plan numbered SCL/G10/0007/1.	Parts of the footpath width will be temporarily closed to facilitate the construction of the pedestrian walkway system at Yuk Wah Street in relation to the Shatin to Central Link.
