

**RAILWAYS ORDINANCE (Chapter 519)  
(Notice under section 23)**

**SHATIN TO CENTRAL LINK**

**NOTICE OF ORDER AUTHORIZING  
TEMPORARY CLOSURE OF  
A STAIRCASE AND FOOTPATH NEAR THE JUNCTION OF  
SHATIN PASS ROAD AND FUNG TAK ROAD;  
THE SECTION OF THE ACCESS ROAD CONNECTING  
WONG TAI SIN ROAD AND SIK SIK YUEN WONG TAI SIN TEMPLE; AND  
SECTIONS OF MA CHAI HANG ROAD, NGA CHUK STREET,  
WONG TAI SIN ROAD, SHATIN PASS ROAD AND FUNG TAK ROAD**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 10 December 2012 (the 'Order'), authorized:—

- (I) the temporary partial closure of a staircase and footpath near the junction of Shatin Pass Road and Fung Tak Road, as delineated and shown in red on the Plan numbered SCL/G08/0008/1;
- (II) the temporary partial closure of the section of the access road connecting Wong Tai Sin Road and Sik Sik Yuen Wong Tai Sin Temple between its junction with Wong Tai Sin Road and a point about 40 metres southwest of the junction, as delineated and shown in pink on the Plan numbered SCL/G08/0008/1;
- (III) the temporary partial closure of the section of Ma Chai Hang Road between its junction with Wong Tai Sin Road and a point about 90 metres west of the junction, as delineated and shown in orange on the Plans numbered SCL/G07/0008/1 and SCL/G08/0008/1;
- (IV) the temporary partial closure of the section of Nga Chuk Street near its junction with Wong Tai Sin Road, as delineated and shown in purple on the Plan numbered SCL/G08/0008/1;
- (V) the temporary partial closure of the section of Wong Tai Sin Road between Ma Chai Hang Road and Shatin Pass Road, as delineated and shown in green on the Plans numbered SCL/G07/0008/1 and SCL/G08/0008/1;
- (VI) the temporary partial closure of the section of Shatin Pass Road between a point 65 metres north of its junction with Fung Tak Road and a point about 50 metres southwest of the junction, as delineated and shown in blue on the Plan numbered SCL/G08/0008/1; and

- (VII) the temporary partial closure of the section of Fung Tak Road between its junction with Shatin Pass Road and a point about 50 metres east of the junction, as delineated and shown in yellow on the Plan numbered SCL/G08/0008/1;

during the period from 1 January 2013 to 31 December 2013 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the staircase, the footpath and the areas of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of this notice will be affixed on or near the staircase, the footpath and the roads affected by the Order on 14 December 2012.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the staircase, the footpath and the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the staircase, the footpath and the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the staircase, the footpath and the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

(b) The section of the access road connecting Wong Tai Sin Road and Sik Sik Yuen Wong Tai Sin Temple between its junction with Wong Tai Sin Road and a point about 40 metres southwest of the junction, as delineated and shown in pink on the Plan numbered SCL/G08/0008/1.	Parts of the carriageway and footpath widths will be temporarily closed in connection with the construction of railway tunnel and the associated railway facilities of the Shatin to Central Link and the public transport interchange at Wong Tai Sin.
(c) The section of Ma Chai Hang Road between its junction with Wong Tai Sin Road and a point about 90 metres west of the junction, as delineated and shown in orange on the Plans numbered SCL/G07/0008/1 and SCL/G08/0008/1.	Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of railway tunnel and the associated railway facilities of the Shatin to Central Link.
(d) The section of Nga Chuk Street near its junction with Wong Tai Sin Road, as delineated and shown in purple on the Plan numbered SCL/G08/0008/1.	Parts of the carriageway and footpath widths will be temporarily closed to facilitate the construction of railway tunnel and the associated railway facilities of the Shatin to Central Link.
