NOTICE OF ORDER AUTHORIZING TEMPORARY CLOSURE OF SECTIONS OF SAI SHA ROAD, ON YUEN STREET, ON LUK STREET, SLIP ROADS BETWEEN SAI SHA ROAD AND MA ON SHAN BYPASS, SLIP ROAD FROM SAI SHA ROAD TO LOK WO SHA LANE AND A FOOTPATH NEAR MTR WU KAI SHA STATION

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 10 February 2014 (the 'Order'), authorized:—

- (I) the temporary closure of the section of Sai Sha Road westbound between a point about 175 metres northeast of its junction with On Yuen Street and a point about 250 metres northeast of the junction, as delineated and shown in pink on the Plan numbered SCL/G45/0033/1, with details as follows:
 - (a) from 1.00 a.m. to 5.00 a.m. during the periods of (i) 14 to 17 April 2014, (ii) 22 to 26 April 2014, (iii) 28 to 30 April 2014, (iv) 2 to 3 May 2014, (v) 7 to 10 May 2014, (vi) 12 to 17 May 2014, (vii) 14 to 19 July 2014, (viii) 21 to 26 July 2014, (ix) 28 July to 2 August 2014, (x) 4 to 9 August 2014, (xi) 10 to 13 September 2014, (xii) 15 to 20 September 2014, (xiii) 22 to 27 September 2014, (xiv) 29 to 30 September 2014, (xv) 3 to 4 October 2014, and (xvi) 6 to 11 October 2014, with all carriageways and parts of the footpath widths of the sections of the road closed; and
 - (b) from 1 March 2014 to 28 February 2015, except the periods specified in (I)(a) above, with parts of the carriageway and footpath widths of the sections of the road closed; and
- (II) (a) the temporary partial closure of the sections of Sai Sha Road between a point about 150 metres southwest of its junction with On Yuen Street and a point about 175 metres northeast of the junction, and between a point about 250 metres northeast of its junction with On Yuen Street and a point about 280 metres northeast of the junction, as delineated and shown in orange on the Plan numbered SCL/G45/0033/1;

- (b) the temporary partial closure of the section of On Yuen Street between its junction with Sai Sha Road and a point about 45 metres north of the junction, as delineated and shown in green on the Plan numbered SCL/G45/0033/1;
- (c) the temporary partial closure of the section of On Luk Street between its junction with Sai Sha Road and a point about 60 metres south of the junction, as delineated and shown in red on the Plan numbered SCL/G45/0033/1;
- (d) the temporary partial closure of the section of Sai Sha Road (and its adjacent footpath and cycling track) between the footbridge near MTR Wu Kai Sha Station and a point about 140 metres east of its junction with its slip road to Lok Wo Sha Lane, as delineated and shown in orange on the Plan numbered SCL/G46/0018/2;
- (e) the temporary partial closure of sections of the slip roads between Sai Sha Road and Ma On Shan Bypass, as delineated and shown in yellow on the Plan numbered SCL/G46/0018/2;
- (f) the temporary partial closure of the section of the slip road from Sai Sha Road to Lok Wo Sha Lane, as delineated and shown in blue on the Plan numbered SCL/G46/0018/2; and
- (g) the temporary closure of the section of the footpath near MTR Wu Kai Sha Station, as delineated and shown in green on the Plan numbered SCL/G46/0018/2.

during the period from 1 March 2014 to 28 February 2015,

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the roads, or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.

SCHEDULE

The roads to be affected

Description of the works and the manner in which the roads will be affected

(a) The section of Sai Sha Road westbound between a point about 175 metres northeast of its junction with On Yuen Street and a point about 250 metres northeast of the junction, as delineated and shown in pink on the Plan numbered SCL/G45/0033/1. From 1.00 a.m. to 5.00 a.m. during the periods of (i) 14 to 17 April 2014, (ii) 22 to 26 April 2014, (iii) 28 to 30 April 2014, (iv) 2 to 3 May 2014, (v) 7 to 10 May 2014, (vi) 12 to 17 May 2014, (vii) 14 to 19 July 2014, (viii) 21 to 26 July 2014, (ix) 28 July to 2 August 2014, (x) 4 to 9 August 2014. (xi) 10 to 13 September 2014, (xii) 15 to 20 September 2014, (xiii) 22 to 27 September 2014, (xiv) 29 to 30 September 2014, (xv) 3 to 4 October 2014, and (xvi) 6 to 11 October 2014, with all carriageways and parts of the footpath widths will be temporarily closed in connection with modification works of the MTR Ma On Shan Station in relation to the Shatin to Central Link.

Except the periods specified above, parts of the carriageway and footpath widths will be temporarily closed in connection with the modification works of the MTR Ma On Shan Station in relation to the Shatin to Central Link.

(b) Sections of Sai Sha Road between a point about 150 metres southwest of its junction with On Yuen Street and a point about 175 metres northeast of the junction, and between a point about 250 metres northeast of its junction with On Yuen Street and a point about 280 metres northeast of the junction, as delineated and shown in orange on the Plan numbered SCL/G45/0033/1.

Parts of the carriageway and footpath widths will be temporarily closed in connection with the modification works of the MTR Ma On Shan Station in relation to the Shatin to Central Link.

Description of the works and the manner in which the roads will be affected

(c) The section of On Yuen Street between its junction with Sai Sha Road and a point about 45 metres north of the junction, as delineated and shown in green on the Plan numbered SCL/G45/0033/1. Parts of the carriageway and footpath widths will be temporarily closed in connection with the modification works of the MTR Ma On Shan Station in relation to the Shatin to Central Link.

(d) The section of On Luk Street between its junction with Sai Sha Road and a point about 60 metres south of the junction, as delineated and shown in red on the Plan numbered SCL/G45/0033/1. Parts of the carriageway and footpath widths will be temporarily closed in connection with the modification works of the MTR Ma On Shan Station in relation to the Shatin to Central Link.

(e) The section of Sai Sha Road (and its adjacent footpath and cycling track) between the footbridge near MTR Wu Kai Sha station and a point about 140 metres east of its junction with its slip road to Lok Wo Shan Lane, as delineated and shown in orange on the Plan numbered SCL/G46/0018/2. Parts of the carriageway, footpath and cycling track widths will be temporarily closed in connection with the modification works of the MTR Wu Kai Sai Station in relation to the Shatin to Central Link.

(f) Sections of the slip roads between Sai Sha Road and Ma On Shan Bypass, as delineated and shown in yellow on the Plan numbered SCL/G46/0018/2. Parts of the carriageway and footpath widths will be temporarily closed in connection with the modification works of the MTR Wu Kai Sai Station in relation to the Shatin to Central Link.

(g) The section of the slip road from Sai Sha Road to Lok Wo Sha Lane, as delineated and shown in blue on the Plan numbered SCL/G46/0018/2. Parts of the carriageway and footpath widths will be temporarily closed in connection with the modification works of the MTR Wu Kai Sai Station in relation to the Shatin to Central Link.

(h) The section of the footpath near MTR Wu Kai Sha Station, as delineated and shown in green on the Plan numbered SCL/G46/0018/2. The footpath will be temporarily closed in connection with the modification works of the MTR Wu Kai Sai Station in relation to the Shatin to Central Link.
