NOTICE OF ORDER AUTHORIZING TEMPORARY CLOSURE OF A SECTION OF LUEN YEE ROAD

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 6 November 2015 (the 'Order'), authorized the temporary partial closure of the section of Luen Yee Road between its junction with Choi Hung Road and a point about 65 metres north of the junction, as delineated and shown in blue on the Plan numbered SCL/G11/0034/2, during the period from 4 December 2015 to 30 September 2016 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the section of the road to be affected and the manner in which it will be affected is given in the Schedule below.

Notice is hereby given that further closure of the same part or parts of the road or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
