## RAILWAYS ORDINANCE (Chapter 519) (Order under section 22(1))

## SHATIN TO CENTRAL LINK

AUTHORIZATION FOR
PERMANENT CLOSURE OF SECTIONS OF LUNG POON STREET;
TEMPORARY CLOSURE OF SECTIONS OF WONG TAI SIN ROAD,
SHATIN PASS ROAD, YING FUNG LANE, FUNG TAK ROAD, AND
THE ACCESS ROAD CONNECTING WONG TAI SIN ROAD AND
SIK SIK YUEN WONG TAI SIN TEMPLE; AND
TEMPORARY ALTERATION OF A STAIRCASE AND FOOTPATH
NEAR THE JUNCTION OF SHATIN PASS ROAD AND FUNG TAK ROAD

In exercise of the powers delegated by the Secretary for Transport and Housing, I, by this order made under section 22(1)(a) of the Railways Ordinance (Chapter 519), authorize:—

- (I) the permanent closure of part of the footpath widths of the section of Lung Poon Street between a point about 25 metres southwest of its junction with Fung Tak Road and a point about 28 metres southwest of the junction, parts of the footpath widths of sections of Lung Poon Street at the points about 30 metres and 40 metres southwest of its junction with Fung Tak Road, and part of the footpath widths of the section of Lung Poon Street between a point about 44 metres southwest of its junction with Fung Tak Road and a point about 52 metres southwest of the junction, as delineated and shown in red on the Plan numbered SCL/G09/0007/4 with effect from 21 December 2017; and
- (II) (a) the temporary partial closure of the section of Wong Tai Sin Road between Ma Chai Hang Road and Shatin Pass Road, the section of Shatin Pass Road between a point about 65 metres north of its junction with Fung Tak Road and a point about 50 metres southwest of the junction, the section of Ying Fung Lane between its junction with Fung Tak Road and a point about 20 metres south of the junction, and the section of Fung Tak Road between its junction with Shatin Pass Road and a point about 50 metres east of the junction, as delineated and shown in green, blue, brown and yellow respectively on the Plan numbered SCL/G08/0008/4;
  - (b) the temporary partial closure of the section of the access road connecting Wong Tai Sin Road and Sik Sik Yuen Wong Tai Sin Temple between its junction with Wong Tai Sin Road and a point about 40 metres southwest of the junction, as delineated and shown in pink on the Plan numbered SCL/G08/0008/4; and
  - (c) the temporary alteration of the staircase and footpath near the junction of Shatin Pass Road and Fung Tak Road, as delineated and shown in red on the Plan numbered SCL/G08/0008/4,

during the period from 21 December 2017 to 20 December 2018.

I further declare under section 22(1)(c) that all public or private rights in, upon, under or over (i) the sections of the road as described in (I) above with effect from 21 December 2017; and (ii) the sections of the roads, the staircase and the footpath as described in (II) above during the period from 21 December 2017 to 20 December 2018, shall be extinguished, modified or restricted, as the case may be.
