

**RAILWAYS ORDINANCE (Chapter 519)
(Notice under section 23)**

SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
PERMANENT CLOSURE OF SECTIONS OF FUNG TAK ROAD,
PO KONG VILLAGE ROAD AND SHEUNG FUNG STREET; AND
TEMPORARY CLOSURE OF SECTIONS OF FUNG TAK ROAD,
PO KONG VILLAGE ROAD AND LUNG CHEUNG ROAD**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 5 December 2017 (the ‘Order’), authorized:–

- (I) (a) the permanent closure of part of the footpath widths of the section of Fung Tak Road near its junction with Po Kong Village Road, as delineated and shown in blue on the Plan numbered SCL/G09/0015/6;
- (b) the permanent closure of part of the footpath widths of the section of Po Kong Village Road at a point about 80 metres northeast of its junction with Shung Wah Street, as delineated and shown in green on the Plans numbered SCL/G09/0015/6 and SCL/G10/0009/12; and
- (c) the permanent closure of part of the footpath widths of the section of Sheung Fung Street at its junction with Wan Wah Street, as delineated and shown in purple on the Plan numbered SCL/G10/0009/12,

with effect from 1 January 2018; and

- (II) the temporary partial closure of the section of Fung Tak Road between a point about 80 metres east of its junction with Po Kong Village Road and a point about 60 metres west of the junction, the section of Po Kong Village Road between a point about 255 metres north of its junction with Fung Tak Road and a point about 120 metres south of the junction, and sections of Lung Cheung Road adjacent to Fung Tak Park, as delineated and shown in beige, red and yellow respectively on the Plan numbered SCL/G09/0015/6 during the period from 1 January to 30 June 2018,

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered SCL/G09/0015/6 and SCL/G10/0009/12 (the ‘Plans’) may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:–

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
